Sub: Continuously being subject to mental and physical cruelty by our daughter in law Rimpa Sarkar, daughter of Ashit Sarkar, with an intention to extort money from us and also to oust us from our residential house so as to grab the said property.

Respected Sir,

In connection with the above, I the undersigned would like to state you that my son Anirban Dey (since deceased) during his lifetime got married to Rimpa Sarkar as per Hindu rites and customs on 28.06.2022 and the said marriage was arranged by both the families. My son used to run my printing press business and earn his livelihood and used to reside at my house with his wife. Since the inception of marriage his wife Rimpa Sarkar is/was intended to grab the printing press business as well as my residential house property and with the said intention she used to put pressure upon my son and also used to ill behave with me and my wife Sujata Dey and her such behaviors is/was supported and instigated by her parents and other family members. Due to her ill behaviors with my son and us, several incidents of quarrel took place between her and my son and upon such inhumane pressure put upon my son to get the properties in his name from me, my son often used to ill behave with me for the demand of property. Out of the wedlock with my son, Rimpa Sarkar gave birth to a girl child named Radhika Dey and she is presently aged about 2.5 years. It is pertinent to mention here that since the inception of marriage my son has been residing with his wife separately in the ground floor of my house and we never did interfere in their personal life in any manner whatsoever. Due to this continuous torture upon my son by his wife with an intention to grab the property from me, my son suffered an hurt attack on the night of 10th of January and succumbed to death. After his demise the magnitude of torture by our daughter in law Rimpa Sarkar increased manifold and she continuously started demanding the residential house property from me and my wife and on our refusal to alienate the same she used to torture me and my wife. We have tried to suffice her demand and provided financial assistance for their subsistence and well being as per our financial

capacities but she craved for more. She, on a regular basis is subjecting us to physical and mental cruelty just with a demand to alienate the property in her name. Very recently, on 04.05.2025 she tortured and assaulted us manifold with a demand to alienate the property in her name. It is pertinent to mention here that my wife is mentally ill and cannot bear the torture inflicted upon her by our daughter in law.

As the torture inflicted upon me and my wife by our daughter in law became unbearable as such I am hereby compelled to lodge this complaint against my daughter in law for physical and mental cruelty inflicted upon us for demand of property and to extort money from us and would request you to take necessary action against her as per law.
