Defamation, Abusive Messaging, and Character Assassination.

Respected Sir,

I, Sri Deepak Kumar More, Son of Sri Bharat Kumar More, resident of Gandhi Nagar, Near Milton English School, Sevoke Road, Siliguri - 734001, Police Station - Bhaktinagar, District- Jalpaiguri would request you to lodge an FIR against Sri Ayush Agarwal, (Mobile No. 8001114156 / 7908704245), Son of Sri Pawan Kumar Agarwal, resident of Munna Building, 3rd Floor, Sri Basant path Road, Prakash Nagar, Siliguri.

At the very outset I request your good office to kindly refer to my earlier complaint diarized as General Diary Entry GDE No.1652 dated 25.02.2025, where I had earlier reported that Ayush Agarwal had threatened me over a phone call and your good office had duly taken cognizance of the matter. However, the said Ayush Agarwal in utter violation of law is continuing to harass me for the past three (3) days. Ayush Agarwal has been sending defamatory Whatsapp messages calling me a "thief", using vulgar, abusive, and slanderous language, intentionally attempting to harm my personal and family reputation, circulating my photograph in various WhatsApp groups without my consent which I anticipate maybe misused by any person illegally. He has shared messages all over whatsapp groups stating that my sister in law has something fishy with me. The said Ayush Agarwal through his acts and conducts has in fact showcased me as a person who shares illicit relation with his own sister-in-law. My pictures and the lewd messages have been widely circulated by him which has harmed my reputation and has defamed me publicly.

The said Ayush Agarwal has also falsely maligning a sacred relationship between me and my sister-in-law by making baseless and disgusting remarks thereby attempting to disgrace both me and my family socially and morally. The said act has is also an attempt to outrage the modesty of a woman. These actions are deliberate, targeted, and aimed at tarnishing my reputation, dignity,

invading my privacy, and causing deep mental anguish to me and my loved ones.

In the aforesaid circumstance, I request your office to immediately intervene and take all necessary actions in accordance with the appropriate provisions of Criminal Law and Information Technology Act against the said Ayush Agarwal and ensure that my safety, dignity and reputation is unharmed and ensure that criminal law is set into motion.
