Bhaktinagar, District- Jalpaiguri in the State of West Bengal would like to lodge this Written Complaint to the Effect that, I had fallen in love with one HABIB CHAUDHARI, Late Abdul Majid resident of Netaji Sarani, Paresh Nagar, Ward No. 44 S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri and due to such love and affairs relation we entered into a matrimonial tie and our marriage was solemnized and registered before the Ex-Officio Marriage Registrar namely Sri Dipak Roy at Jalpaiguri on 25.08.2013 and after the elapse of three months on 09.11.2013, I along with my husband shifted to a rented house of Saidul Haque situated Near Community Hall, Community Hall Road, Ward No. 40 S.M.C., P.O. Sevoke Road, P.S.-Bhaktinagar, Dist-Jalpaiguri and our marriage was duly consummated at the above mentioned address and after elapse of nine days my husband took me to his paternal house situated at Naya Haat, Luinsipakhri, P.S. Phansidewa, District- Darjeeling and my Nikah was conducted there as per the Muslim rites and customs on 18.11.2013 and after Nikah, I along with my husband shifted to rented house of Saidul Haque situated Near Community Hall, Community Hall Road, Ward No. 40 S.M.C., P.O. Sevoke Road. P.S.-Bhaktinagar, Dist-Jalpaiguri .

Sir, it is to be mentioned here that soon after my marriage, I came to know about the bad habits of my husband like gambling, consuming alcohol regularly and whenever I used to request my

husband to mend his ways, he used to assure me that he will forsake such bad habits but on each and every day he used to do such things as above mentioned and soon after elapse of two months of my marriage, my husband had assaulted me very badly for the very first time and I was traumatized and I was unable to disclose the same fact to anyone of my family members as I has married a person(Inter-Religion) against the will of my parents.

Sir, it became regular routine like situation, my husband used to assault me at night regularly after consuming alcohol and on every following morning he used to solve the matter by begging and requesting me and even blackmailing me for dire consequences as my parents does not supported me for marrying a person belonging to some other religion.

Sir, on 23.03.2016, I gave birth to a female child namely Miss. Mahin Parveen at Akash Nursing Home, Siliguri and after the birth of my daughter the situation was going smoothly without any dispute till next two years, but after elapse of two years my husband again started the same assault on regular basis and sometimes he used to oust me from the house even in winter season.

Sir, it is to be mentioned here that my husband abuses me with very filthy language and he also calls me with very much derogative names and words before the neighbors to malign my reputation in the society and he always creates tremendous mental torture and pressure upon me to leave the matrimonial house so that he can marry some another lady.

Sir, on 08.06.2025 at about 10:00 P.M. at night when I was talking with my sister over phone at that point of time my husband came and assaulted me with fists and blows on my forehead and due to such assault I sustained grievous cut

injury on my forehead and he further ousted me from the house without even giving me any medicine and at that time he was continuously abusing me with filthy and abusive languages.

Sir, after such assault as blood was coming out from my forehead, I went to Siliguri District Hospital for treatment and the attending Doctor prescribed me some medicines and advised me for conducting Stitches on my forehead, but considering my such situation I request them only to medicate me.

Sir, since the last night i.e. on 08.06.2025 my husband is not allowing me to enter into my matrimonial house and he is threatening over phone that he shall kill me if I enter into the matrimonial house and finding no other alternative I have taken shelter in my neighbor's house.

Sir, I have informed about his such acts on multiple times before Ashraful Masjid and Councillor of Ward 40 S.M.C. and near relatives of my husband and they had arranged meetings on multiple occasions but no fruitful result has come and my husband does not bear any kind of expenses towards me.

Therefore, in above such situation I am in great fear and taking the shelter of law, Kindly do needful as per law against my husband.
