Respected Sir,

I, Dolly Ghosh, Wife of Sri Sasti Ghosh, resident of Dr. R.P Sarani, Siliguri, Ward No 06 Of SMC, o Pin-734001, would like to inform you that my daughter-in-law namely Smt. Sampadika Pan (phone number- 9883916630), daughter of Tapan Kumar Pan, permanent resident of Mahr Maheshpur, was married to my son Sri Abhinav Ghosh on 21-01-2014. After the marriage my Son Abhinav Ghosh and she started living and cohabitating together as husband and wife at the present resident as mentioned above as joint family. That since the inception of the marriage, she used to create chaos in the family and constantly forced my son to leave the house and reside in a separate residence. That when my son refused to do the same, she used to create chaos at the house with my son. That she also used to mentally pressurize me to handover all my locker keys to her which contains all my family belongings i.e., gold, cash etc. and constantly forced me to talk my husband to divide the undivided property and transfer the name of the portion that will belong to my son in the near future in her name. That she also talked very ill regarding me and my family defaming us in the society. That she is a woman of materialistic greed and whenever we couldn't fulfil her demands, she used to threaten us that she will file false cases against me and my family members.

It is pertinent to mention here that she had a disliking towards my dog from the very beginning where on some occasions I caught her feeding substances which are poisonous to dogs which can be fatal if fed. When I confronted her about the same, she used smile and say that feeding one will not cause harm, which subsequently my dog then suffered from severe health issues.

That after years of mental torture and trauma by my Daughter-in-law, she decided to live separately at our residence but on the different floor, therefore living under the same roof but never making any contacts with us. That she lives by herself but does not take any care of me and my old aged husband despite every basic necessities being provided by us. That it has come to my knowledge that she is currently working at a pharmacy store in BD Enterprise at Mitra Sanmilani, Siliguri and works between 11.AM to 8 P.M approx. That leaves and enters the above-mentioned residential premises at her own will and fancy. That we have also been informed by our neighbours that they have seen her on various occasions entering our house late at night. That when we confronted her about this, she started abusing me and my husband with filthy languages and claimed that she will do whatever she wants and if we tried to stop her, she will make our lives miserable.

That yesterday morning i.e., 09-05-2025 at around 10 A.M., my daughter-in-law came upstairs when I and daughter was alone and slammed the door open and entered our floor, while all this, my senior dog started barking when she tried to attack us, she kicked my dog which resulted him into limping, bad shape and immense pain. Hearing the chaos I

and my daughter ran towards the front door where my daughter-in-law was standing with a broken bamboo, upon seeing us she started abusing us with filthy languages and tried to attack us with the bamboo to hit us. She then pushed me and I fell on the floor and got hurt in my left knee, back of my head and elbow. When my daughter came to help me to get up, she pushed her as well and caught her by her hair and threatened me and my daughter to pay a lumpsum amount. She also threatened us with dire consequences and told us that if we do not pay her the amount that is demanding then she will file false cases against us and make us suffer forever. She then continues to threaten me saying that she will drag all of us in courts and acquire every single piece of my family's belonging leaving us begging on the roads. That during this turmoil I was wearing a gold chain weighing around 8 gms which she tried to snatch, that when I was refusing, my chain tore and fell on the ground, she then picked it up and left our floor.

It is pertinent to mention here that, due to the daily quarrels my son shifted at a rented premises at Shivmandir, when my son had asked her to stay with him, she denied and refused to shift. Thereafter, my daughter-in-law stays at the 1st floor of the said residential address occupying two rooms on that floor. That we had asked her many times give us access to the rooms as we might need them at times, but she refused and does not let us enter the floor anymore.

That I have been under immense pain since the incident yesterday morning and to seek help I rushed to the Siliguri District Hospital where I treated. That I am under extreme distress and I am scared for the wellbeing and peaceful living of me and my daughter. Hence I, hereby pray before your goodself that an immediate action be taken against the said Sampadika Pan according to the due process of law.
