With due regards, we are writing to you on behalf of the **2nd Mile Milestone Shop Owners Association**, which represents all the shop owners and business establishments operating within the **Milestone Building**, situated at **2nd Mile Check Post, Sevoke Road, Opposite Bhaktinagar Thana, Siliguri**.

This letter is in continuation of our earlier correspondence dated **05.11.2024**, a copy of which is enclosed herewith for your reference. We wish to bring to your immediate attention a matter of serious concern that occurred within our building premises yesterday.

Asha Chourashiya (wife of Mr. Kamal Chorasiya), who is running a wayside shop in the lane beside Milestone Building, appeared to be in an inebriated state, unlawfully entered the compound of our building yesterday (09.05.2025) and caused damage to a parked vehicle. In addition to the property damage, she also verbally abused both our caretaker and the on-duty security guard, thereby creating a scene of disorder and distress for those present.

We earnestly request that the matter be looked into with urgency. We kindly urge you to take appropriate and timely action to identify and apprehend the individual involved, and to implement necessary measures to ensure such disruptive behaviour is not repeated by anyone in the future.

We trust that you will treat this issue with the seriousness it warrants and assist us in maintaining a safe and secure environment for all.
