I, Jaydeb Barman, Son of Manoranjan Barman aged about 36 years, Hindu by faith, Labour by occupation, permanent resident of Chantanya Pur, Tarl, Rangia, P.O New Rangia, P.S Matigara, Dist Darjeeling in the State of West Bengal would like to inform you as follows: -

- That Miss Jamuna Barman, D/o Jaydeb Barman is my minor daughter (14 years) and on 04/04/2025 at around 6:45 am she had gone for her regular tuition in her by-cycle.
- 2. That at around 7:30 am on the same day I got a call from 8159962060 who is a local and he drives toto in the locality, whereby he informed me that my daughter met with an accident at chatanya pur, with a tipper and has been admitted to NBMCH (Darjeeling) Siliguri and hearing such news I immediately rushed to medical college where I learned that vehicle bearing registration No WB-78-8243 (Tipper) was responsible for causing the accident and after the accident there was chaos on the road and due to the pressure from the locals present at the spot the driver of the tipper namely "Dhakuru" had taken and admitted my daughter to medical college and she was taken in the toto of the local who informed be about the accident.
- That by the time I reached the hospital the owner of the tipper namely "Ghanashyam Singha" was also present there.
- 4. That sir the said Ghanashyam Singha later gathered some people claiming to be the members of tipper association and all of them pressurized me not to report the incident to the authorities and they further promised me to bear all medical expenses that might occur for the treatment of my daughter.
- 5. That sir I am a daily wage labour and am responsible for earning bread for my family consisting of my wife and two daughters and I cannot afford better treatment for my daughter as such I have been occupied running door to door in order to secure money for the treatment of my daughter as such I have could immediately report the incident to the authorities.
- 6. That sir I have been running from one hospital to another for seeking cost effective treatment of my daughter and during all this time I have been financially drained and I am in miserable debt to my relatives but the injuries caused to my daughter due to the accident is worsening day by day and a urgent surgery is required in order to prevent further infection.
- That yesterday dated 07/05/2025 I had contacted the said Ghanashyam Singha to keep up his
  promise but he refused to pay a penny and suggested me to file a case against him.

Therefore, in the light of the above facts I hereby request you to kindly initiate necessary action against the driver, the vehicle owner and his accomplice for the ends of justice.
