Jalpaiguri, through Facebook, And after 5 /6 months we both fell in love and a love affair begins between us, it is pertinent to be mentioned here that, After a few days, When a serious love affair begins between us, the said Asim Biswas physically intimated with me and takes photos and videos of our intimate moments without my knowledge & without taking any permission from me. After elapse of some time I came to know that the said Ashim Biswas is a addict person, And After knowing this, I thought about breaking off my love relationship with Ashim Biswas.
