I, ASI Dhurbo Misra (Ph-9933805213) s/o Abani Misra of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above accused persons and 3/4 others to the effect that on 11.05.25 at 00.10 hrs received a specific source information that 9/10 miscreants have assembled at P.C. Mittal bus stand under Bhaktinagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhakti Nagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No-510 dated 11.05.2025 and as per order I along with SI Srimanta Chatterjee, SI Yuel Lepcha, ASI Khagen Barman, ASI Amal Barman with force (K-37) van with C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for P.C. Mittal bus stand under Bhakti Nagar PS, to work out the information in hand vide Bhaktinagar PS GDE No-511 dated 11.05.2025..

At about 00.30 hrs we reached at 11.05.2025 being indicated by the source we noticed that 09/10 persons were assembled at 11.05.2025 under Bhakti Nagar PS, and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we police party somehow managed to apprehended above noted 05 (five) of them with deadly weapons in their possession but 3/4 persons managed to fled away from the spot taking the advantage of darkness and open place. On

ASI- Dhrulen Ullein BKM PSISPE dt-11105125. interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 11.05.25 in between 00.45 hrs and 01.20 hrs. The whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted (1) Sujit Tamang-22yrs s/o Lalit Tamang of Ratanlal busty, Ward No-3, PS Pradhannagar Dist Darjeeling (2) Avijeet Roy-20yrs s/o Oleswar Roy of Bottle company bazaar, ward no-41 PS Bhaktinagar Dist Jalpaiguri (3) Bishnu Barman-27yrs s/o Lt Subhash Barman of Vivekanandanagar, ward no-42 PS Bhaktinagar Dist Jalpaiguri (4) Sanju Das-22yrs s/o Dhiren Das of Amtala, Bottle Company, ward no-41, PS Bhaktinagar Dist Jalpaiguri (5) Satya Kumar-25yrs s/o Sri Ram Kumar of Vivekanandanagar, near Shiv mandir, ward no-42 PS Bhaktinagar Dist Jalpaiguri and 3/4 others kindly arrange for its investigation
