Sir,

With due respect, I, SMT. MALATI ROY, Wife of Late Tarani Roy, Resident of Shantipara East, P.O. Bhaktinagar, P.S.- Bhaktinagar now N.J.P., Dist- Jalpaiguri, Pin- 734007, beg to inform you that I am the absolute owner in possession of land measuring 05 Katha 04 Chhataks or 8.66 Decimals recorded in R.S. Khatian 778, situated in R.S. Plot No. 145/715, situated within Mouza – Binnaguri, Sheet No. 11, J.L. No. 3, P.S. – Bhaktinagar (now N.J.P.), Dist- Jalpaiguri by virtue of Registered Deed of Sale being No. 2419 for the year 2003, Recorded in Book No. I, Volume No. 32; Pages from 153 to 156, registered at the office of Sub- Registrar Rajganj, Dist. Darjeeling and I have also made/constructed a pucca boundary wall around my land. Since then I am in possession of the said landed property. It is pertinent to mention herein that after the purchase of the aforesaid land, my husband was diagnosed by cancer and me and my family had been suffering tremendous mental agony and financial crisis therefrom and finally in the year 2009 my ailing husband died and since then me and my only daughter had been troubled and faced various difficulties in our daily life. I have been paying khajna in respect of the aforesaid land regularly.

In the month of March, 2024 some miscreants namely (1) SRI BASANT KUMAR, Son of Late Bharat Prasad, (2) SMT. ANJU DEVI, Wife of Sri Basant Kumar, Both are resident of Eshana Apartment, 3rd Floor, 3A, Tarashankar Road Bye Lane, Deshbandhu Para, Opposite 02 No. Sishu Vidyalaya, Ward No. 29 S.M.C., P.O. Siliguri Town, P.S. Siliguri, Dist- Darjeeling, Pin- 734004 (W.B.), (3) SMT. SHOBHA KUMARI @ SHOVA, Wife of Sri Anil Kumar, Resident of Kashipur, Ward No. 10, P.O. Bidupur (R.S.), P.S. Rajapakar, Dist- Vaishali, Bihar, Pin- 844502, (4) HUMAYUN KABIR, Son of Maksed Ali, of Vill- Jorpakhuri, P.O. Sahudangi Hat, P.S. Bhaktinagar, Dist- Jalpaiguri (5) ANIL BHOWMICK, Son of Nibaran Bhowmick, Of Chaturagachh, P.O. Sahudangi Hat, P.S. N.J.P., Dist- Jalpaiguri (6) AFAZ ALI, Son of Ahamad Ali, (7) JAHIRUL ISLAM, Son of Sakin Ali, Both are resident of Vill- Jorpakhuri, P.O. Sahudangi Hat, P.S. Bhaktinagar, Dist- Jalpaiguri along with their other antisocial associates, who are financially strong and politically connected, came to me and threatened me that I have to sell out my aforesaid landed property to them in very low price otherwise they will dispossess us from the said land by force and if I will try to stop them then me and my family shall face dire
