Said Siddarth mahato laughing and saying "AUR MAR AUR MAR". This is not the single incident that had been occurred, Previously they have also beaten to my younger brother Yash Mahato badly over on the same issues of illicit relationship. They both roaming her and there without any shy or hesitation. when My father wanted to raise the question or say any things about them, my Mother starts threatening to file another false dowry case or will kill my grand mother in odd hour in absence of no one. My grand mother had been attacked by her with knife in last occasion and given a complain to your good office and as well to Siliguri Police Commissionerate office regarding attempting to murder .Sir, This is not one day or two day story, every day there are disturbance that are created by them. On earlier occasion, there was CCTV Camera in the varandha or in front of gate. They were afraid and be very cautious under the surveillance of CCTV Camera, their illicit relationship may not recorded within the

camera. There was not any incident of fighting, shouting or any type of other incidents among the our family. They have broken the camera twice occasion because of their illicit act has been recorded. Sir, I am lodging this complain to your good office in presence of my father.
