In producing herewith the following two (02) accused persons namely (i) Bijoy Singha (32 yrs) S/O Suresh Singha of Kalabari, PO-Adhikari, PS Khoribari, Dist- Darjeeling and ii) Nakul Deb (35 yrs) S/O Kamal Deb of Damravita, PO Adhikari, PS Khoribari, Dist-Darjeeling, under arrest and the following seized articles under proper seizure list viz:

- (i) One (01) white colour plastic container (drum) containing approx 10 (ten) litres of country made illicit liquor locally called as "CHOLAI" Marked as Exhibit-"A" out of which approx 500 ml of the same taken in a separate bottle as sample for examination and marked as Exhibit "A1.
- (ii) One (01) white colour plastic container (drum) containing approx 10 (ten) litres of country made illicit ID liquor locally called as "CHOLAI" Marked as Exhibit-"B" out of which approx 500 ml of the same taken in a separate bottle as sample for examination and marked as Exhibit "B1.
- (iii) One (01) white colour plastic container (drum) containing approx 10 (ten) litres of country made illicit ID liquor locally called as "CHOLAI" Marked as Exhibit-"C" out of which approx 500 ml of the same taken in a separate bottle as sample for examination and marked as Exhibit "C1.
- (iv) One (01) white colour plastic container (drum) containing approx 10 (ten) litres of country made illicit ID liquor locally called as "CHOLAI" Marked as Exhibit-"D" out of which approx 500 ml of the same taken in a separate bottle as sample for examination and marked as Exhibit "D1.
- (v) One (01) white colour plastic container (drum) containing approx 10 (ten) litres of country made illicit ID liquor locally called as "CHOLAI" Marked as Exhibit-"E" out of which approx 500 ml of the same taken in a separate bottle as sample for examination and marked as Exhibit "E1.
- (vi) One (01) white colour plastic container (drum) containing approx 10 (ten) litres of country made illicit ID liquor locally called as "CHOLAI" Marked as Exhibit-"F" out of which approx 500 ml of the same taken in a separate bottle as sample for examination and marked as Exhibit "F1.
- I, ASI Biplab Kumar Das, of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against above noted two accused persons namely (i) Bijoy. Singha. (32.;yrs) S/O Suresh Singha of Kalabari, PO-Adhikari, PS Khoribari, Dist-Darjeeling and ii) Nakul Deb (35 yrs) S/O Kamal Deb of Damravita, PO Adhikari, PS Khoribari, Dist.- Darjeeling to the effect that on 12.05.2025 at 14:20 hrs I received a reliable specific source input that two persons possessing and carrying huge quantity of illegal illict I/D liquor locally called as "CHOLAI" without any valid licence would be come to deliver the same to their designed customers.

Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 602 dated 12.05.25 and I informed the matter to you. Subsequently, being directed by you myself accompanied with St Goutam Mallik, St Bandhan Roy, ASt Prabal Sarkar and force all of Pradhan Nagar PS, SPC left for Apollo crossing, front of Sarda Auto care petrol pump under Pradhan Nagar PS, Dist. Darjeeling by Govt. vehicle to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford him opportunity for concealment of evidence or facility for his escape.

At about 14.45 hrs I along with the above mentioned officers and force arrived at Mallaguri under PS- Pradhan Nagar, Dist. Darjeeling and contact with the source while he stated that the said persons possessing illicit ID liquor in the evening. Accordingly, we are waiting there. At around 17.25 hrs I received source information that said two persons possessing illicit ID liquor are standing at Apollo crossing, Mallaguri and they are waiting for their coustomer to deliver the same. Acordingly, we rushed to the spot and from a considerable distance we noticed that two persons were standing there with six numbers of white colour drums. Accordingly, we cordoned the place from every corner and managed to detain them. On interrogation, they disclosed their identity as (i) Bijoy Singha (32 yrs) S/O Suresh Singha of Kalabari, PO-Adhikari, PS Khoribari, Dist- Darjeeling and ii) Nakul Deb (35 yrs) S/O Kamal Deb of Damravita, PO Adhikari, PS Khoribari, Dist.- Darjeeling. On further interrogation they disclosed that they are carrying illicit ID liquor and standing there to deliver the same to there design customers. On search I found 06 numbers of white colour container (Drum) containing approx 10 (ten) litres of illegal illicit ID liquor in each container. On further interrogation they disclosed that they collect the same from Panitanki side and came there by bus to deliver the same to their design customers for their wrongfull gain. On demand they failed to produce any documents in respect of carrying and possessing such illicit ID liquors recovered from their joint possession.

As they willfully violated the norms of Bengal Excise Act, hence, I seized the above noted illegal illicit ID liquor from their joint possession under proper seizure list in presence of witnesses. The entire process of search and seizure was made in between 18.05 hrs to 19.05 hrs under the coverage of videography executed by Somanath Chatterjee S/O Sushil Chatterjee of Gokhel Road, Arabinda Pally, PS- Siliguri, Dist. Darjeeling. Subsequently, I arrested both the above noted detained persons namely (i) Bijoy Singha (32 yrs) S/O Suresh Singha of Kalabari, PO-Adhikari, PS Khoribari, Dist- Darjeeling and ii) Nakul Deb (35 yrs) S/O Kamal Deb of Damravita, PO Adhikari, PS Khoribari, Dist.- Darjeeling after observing all the formalities of arrest and inform him regarding ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation.

Under the above noted fact and circumstances I, therefore pray that a specific case under proper section of law may kindly be started against the above noted arrested accused persons namely (i) Bijoy Singha (32 yrs) S/O Suresh Singha of Kalabari, PO-Adhikari, PS Khoribari, Dist- Darjeeling and ii) Nakul Deb (35 yrs) S/O Kamal Deb of Damravita, PO Adhikari, PS Khoribari, Dist.- Darjeeling for violating the provisions of W.B. Excise Act and may arrange to cause its investigation.
