With due respect, I am producing herewith the 03 (three) arrested accused persons, Roshan Ali (26) S/O Kudush Mohammad of Dry Fish Market, near Kabursthān, P.O. & P.S. Matigara, Dist. Darjeeling. (2)- Sunil Samaddar (34) S/O Subash Samaddar of Lake Town, Near Hazi Briyani, P.S. NJP, Dist. Jalpaiguri. (3)- Shibu Pal (26) S/O Late Buddhadeb Pal of South Ambedkar Colony, Ward no. 1, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling and the following articles under seizure :-


- (1)- One iron made sabol measuring 30 inches (approx.) and one Iron Plash from the possession of Roshan Ali (26) S/O Kudush Mohammad of Dry Fish Market, near Kabursthān, P.O. & P.S. Matigara, Dist. Darjeeling.
- (2)- One iron hammer with wooden handle weighing 07.50 kilograms and one screw driver from the possession of Sunil Samaddar (34) S/O Subash Samaddar of Lake Town, Near Hazi Briyani, P.S. NJP, Dist. Jalpaiguri.
- (3)- One Torch light and one Iron rod measuring 25 inches (approx.) from the possession of Shibu Pal (26) S/O Late Buddhadeb Pal of South Ambedkar Colony, Ward no. 1, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling.

I, ASI Pema Dorjee Sherpa of Matigara PS, Siliguri Police Commissionerate beg to state that on 11.05.2025 at 22:05 hrs. I along with the force left the P.S. for night patrolling mobile van duty and during night patrolling mobile van duty on 12.05.2025 at around 00:05 hrs. received a secret source information that a gang of miscreants were assembled at near Chang more in an abandoned concrete room under Matigara P.S. jurisdiction with deadly weapons and making preparation for committing dacoity at Himachal Vihar area under Matigara PS. Accordingly, I informed the fact to I/C, Matigara PS and as per the kind order of my superior, I along with ASI Bikash Roy, C/523 Sanjit Kundu, C/219 Sanatan Chitrakar, C/868 Sujal Roy all are of Matigara PS, SPC proceeded to Chang more to verify the source information. On 12.05.2025 at around 00:13 hrs. we arrived at near Chang more. Further on arriving at the exact spot as shown by the source we could hear their whispering from the distance. However the spot was inside the barbed wire fencing and somehow we finally find the way in and saw a small abandoned concrete room. Accordingly we cordoned the place and approach towards them very slowly and carefully. However seeing the police party they started to flee away and somehow we managed to apprehend 03 (three) persons. During interrogation they disclosed their identity as noted above (not verified) and also disclosed that they were assembled there for making preparation to commit dacoity at Himachal Vihar area. Furthermore, They admitted that 07/08 of their associates were able to fled away from the spot. On being searched of the apprehended accused persons, found the above noted articles. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 03 (three) accused persons under proper memo of arrest after observing all formalities. The search seizure were made in between 00:17 hrs to 00:27 hrs on 12.05.2025 under proper video graph.

Matigara, Dist. Darjeeling. (2)- Sunil Samaddar (34) S/O Subash Samaddar of Lake Town, Near Hazi Briyani, P.S. NJP, Dist. Jalpaiguri. (3)- Shibu Pal (26) S/O Late Buddhadeb Pal of South Ambedkar Colony, Ward no. 1, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling and others to arrange for its investigation.
