I Beauti Goswami Das W/O, Nilay Goswami R/O Vidya Sagar Pally, Khalpara Siliguri, W/N, 7 P.O- Siliguri Bazar, P.O.- Siliguri, District- Darjeeling, Pin-code- 734005 would like to inform you that my one person namely Subhash Mujumdar S/o, Binod Mujumdar, R/o, Alu Chowdhary more, Babupara w/o, 27 comes under Siliguri municipal corporation who is following me from several days I used to work in the real state which is situated in city center and the above noted person used to follow regularly without having no reason and at the time of 8p.m when I used to go home by walking he always stand near shri shanti honda at Bardawan road and used to look at me very uncomfortably one day I asked him why he use to look at me like that but he said to me that he used to pick his sister so he used to come here I took it casually and I used to complaint against him to my husband namely Nilay Goswami for the act of above noted person therefore today when I was in the office the above noted person directly came to my home without having any information about me how he directly came to my house fully in drunk condition at about 5:10p.m and directly started misbehaving with my husband and used some slang language towards me and my family members at that time suddenly he attacked my husband and asked him where is your wife he physically assaulted my husband with blows and punches and my husband got injury in right hand and some blows in chest and in left leg and waist my husband tried to stop but then also the above noted person tried to continue the assault with the help of well wishers somehow he stopped and he was not in such condition and he was not in control and again and again he was asking about me to my husband and tried to harm peace and tranquillity of the society as well as harming my reputation.

So, under the above circumstances I therefore request you to kindly inquire the matter immediate and record this Complain as F.I.R. and take a necessary legal action against above the noted persons and stop him to do any future criminal act for the ends of justice.
