in producing herewith the accused person namely Sukumar Singha @ Bittu, aged 26 yrs, s/o- Late Suday Singha, resident of Ranidanga, Vidyasagar Pally, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles under proper seizure list:

1. Twelve (12) bottles of Tuborg Strong Premium Beer, each contains 650 ml @ Rs. 160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-A.
2. Twelve (12) bottles of Himalayan Gold 60° UP India Made Liquor, each contains 600 ml @ Rs. 160/-, out of which 01 bottle is taken out as sample and marked as Exhibit-B.

(Total 15 ltrs, total value Rs. 3840/-)

I, SI Binup Mahato of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person namely Sukumar Singha @ Bittu, aged 26 yrs, s/o- Late Suday Singha, resident of Ranidanga, Vidyasagar Pally, PS- Bagdogra, Dist- Darjeeling (not verified) to the effect that on 10.05.2025 at 20:55 hrs received reliable source information that a huge quantity of liquor is stored at the hotel of one suspect Bittu Singha at Ranidanga bus-stand beside Ranidanga Road under PS- Bagdogra and the same has been selling illegally. Accordingly, I informed the matter to O. Bagdogra PS and as per his direction I along with SI Debabrata Kundu, ASI Amit Lama, ASI Munir Ahmed, C/1509 Sourav Roy Sarkar, CV/375 Jogesh Barman & CV/389 Janak Singh left for Ranidanga bus-stand beside Ranidanga Road to work out the secret source information. This refers to Bagdogra I GDE No. 519 dated 10.05.2025. At around 21:15 hrs we reached at Ranidanga bus-stand beside Ranidanga Road and being indication & identification by source we held raid at the hotel of the suspect and detained one person there with the help of accompanying Police personnel and interrogated him. On interrogation, he revealed his identity as Sukumar Singha @ Bittu, aged 26 yrs, s/o- Late Suday Singha, resident of Ranidanga, Vidyasagar Pally, PS- Bagdogra, Dist- Darjeeling (not verified) and introduced himself as the owner of that hotel. We disclosed our identity to him and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. Two independent witnesses namely Mahadev Singha, aged 40 yrs, s/o- Gopesh Ch. Singha, resident of Daraboo Jote, PS- Phansidewa, Dist- Darjeeling and Satiram Singha, aged 60 yrs, s/o- Late Monil Singha, resident of Ranidanga, Khejur More, PS- Bagdogra, Dist- Darjeeling agreed to be present the as witness. Then, we searched the hotel in presence of the independent witnesses as well as the Police personnel. On search, the above noted liquor was recovered from the said hotel. On demand, he failed to produce any valid document/license for possessing, stocking & selling that liquor. He confessed that he had been possessing, stocking & selling liquor illegally from his hotel since long time for his wrongful gain. His involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list and at last, arrested the involved accused Sukumar Singha @ Bittu (as noted above) after observing all legal formalities and communicating him the ground of arrest as he had committed a cognizable offence in presence of Police for possessing, stocking & selling that liquor illegally and issued memo of arrest in this regard. The process of search, seizure & arrest was made between 21:20 hrs and 21:40 hrs on 10.05.2025. The entire process of search, seizure & arrest is documented through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person namely Sukumar Singha @ Bittu, aged 26 yrs, s/o- Late Suday Singha, resident of Ranidanga, Vidyasagar Pally, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for its investigation.
