I SRI. DILU LAKRA, S/o Budhuya Lakra, resident of Gossainpur, Rupsing Jote, P.O. & P.S. Bagadogra, Dist: Darjeeling, West Bengal, Pin: 734014 would like to state as follows:

- 1. That I work as a Purchase and Sales executive manager at M/s Jain Metal Store at Bagdogra from last 5 or more years. That as on 23.04.2025 recently one person's namely Sri Ravi Singh, Son of Unknown along with his brother who introduced himself as the owner of M/s Punjab Gas Store, which deals in wholesale and retail of household utensils located at Jaymani Bhawan Gali, near Venus more, P.O. & P.S. Siliguri approached me to purchase some goods from them for resale.
- 2. That as at the time I didn't have any cash with me to purchase the goods I denied his request but he kept on requesting me and after my continuous denial he offered me to sale the goods on a line of credit for a time period of a month to which I further denied but after his repeated request I called my Employer Sri Mahendra Kumar Jain and asked for his permission to purchase the goods of Rs. 21,990/- on credit on a one-month basis to which my employer accepted and I purchased the goods.
- 3. That subsequently as on 26.4.25 Sri Ravi Singh visited our shop at Bagdogra to check whether we have any further demand for his goods and collect a part payment. That one Sri Surender Saha the manager of the M/s Jain Metal Store paid him Rs.5,000/- on very that day and told that payment of balance amount will be made after a month as agreed as the market is not good. That Ravi Singh agreed.
- 4. That again Sri. Ravi Singh visited our shop as on 03.05.2025 for the very same reason stated above but our store manager requested him that due to poor sales he was not able to make a part payment and promised to repay the remaining balance amount within the one-month time frame as decided.
- 5. That on 10.5.2025, Sri Ravi Singh along with his brother visited our shop but the manager of our shop requested him that due to consistent poor sales and present situation of the market he won't be able to pay any amount but assured him that he would pay the balance remaining amount within a week but all of sudden both Sri Ravi Singh along with his brother started having an aggressive behaviour to collect the payment of balance amount against the goods. That seeing thus my store manager interfered and told them that payment was required to be made after a month and not before that as agreed. But they were adamant to collect the payment of balance amount and used abusive language against me, my manager and my said employer and even broke the floor tiles of our shop by throwing the gas stove heavily on the floor tiles.
