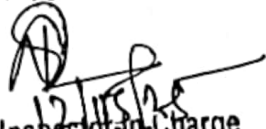
- i. That, I, Sumaria Devi, w/o Tuntun Kumar, s/o Porajhar, Satellite Township, Dist - Jalpaiguri, wants to inform you about the attack done by
(i) Rudal Sahani s/o unknown (ii) Deela Devi w/o Rudal Sahani (iii) Santosh Sahani s/o Rudal Sahani, (iv) Laxmi Sahani d/o Rudal Sahani all resident of Porajhar, Satellite Township, Dist - Jalpaiguri.
- ii. That, the incident took place when my son Rabi Roy, was passing by the road in front of my house wherein the abovenamed Santosh Sahani and Rudal Sahani were sitting. No sooner my son was going through the road, they started abusing my son for no reason and soon I reached there with my son hearing about chaos. I took my son from there and took him back home.
- iii. That, yesterday (11/05/25) at around 10:30 PM, they (the abovenamed) called their relatives namely Arun Sahani and Karan Sahani s/o Tikiyapara Siliguri, along with their other friend and started beating my son, husband and myself in front of my house using steel bangles, iron rods, bamboos.
- iv. That, the fight became so serious that they touched my chest inappropriately, and tore my clothes in public, outraging the modesty of a woman in public. That I was seriously injured and I had to immediately rush to the North Bengal Medical College and Hospital, wherein

was admitted yesterday and was discharged today morning.

That even after the illegal acts, they did not stop, and today (12/05/25) at around 12:30 AM they came and abused and also threatened us that they will beat us again.

Sir we are seriously concerned regarding our safety and request you to take necessary actions as per law.
