Sir.

In producing herewith three (03) accused persons namely (i) Ronit Bhowmik (20) S/O Barun Bhowmik of Mother Teresa Road near payel cinema hall, PS Siliguri Dist Darjeeling (ii) Anisur Rahaman (190 s/o Mansur Alam of Tinbatti over bridge PS NJP Dist Jalpaiguri (iii) Saidul Islam (22) s/o Lt Sarat Ali of Tinbati over bridge, Jyotinmoy Colony War No 32, PS NJP Dist Jalpaiguri under arrest and the following articles under seizure viz,

- (i) One iron made sword approx length 37 inch with iron butt.
- (ii) One iron made Hanswa approx length 23 inch with butt.

(iii) One iron road approx 20 inch.

(iv) One still colour iron made imitation fire arms measuring approx length 8 inch with handgrip and fited with trigger from the possession of accused Saidul Islam.

(v) One red colour charger torch light

(vi) One black colour Mahindra E auto with out number plate with key.

(vii) Four Android phone in different company.

I, SI Tanmay Kundu of NJP PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted three (03) arrested accused persons and their 12/14 unknown associates involved in this crime to the effect that on 13-05-2025 at 01:55 hrs received a specific source information that about 14/15 miscreants assembled at Chunavatti Road in front of TV center under PS- NJP, Dist.- Jalpaiguri equipped with fire arms and deadly weapons and were taking preparation for committing dacoity at Chunavatti and its surrounding area.

Accordingly, I informed the matter to you and diarized the fact in General diary vide NJP PS GDE No 771 dated 12.05.25 and as per your kind order and direction, at about 02.05 hrs. I accompanied with ASI Nilam Swarnakar, C/ 1462 Sajan Tamang VP 08 Laxman Roy VP 13 Jamiru Islam and force of NJP PS left for Chunavatti under NJP PS, Dist.- Jalpaiguri by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for his escape. On the way to Chunavatti, I requited to randam passenger to act as independent witnesses namely (i) Haridas Biswas (37) s/o Lt Harekrishna Biswas of Fulbari Bazar PS NJP Dis Jalpaiguri (ii) Rajib Laskar (24) ns/o Gopal Laskar of Fulbari Super Market PS NJP Dist Jalpaiguri and inform them regarding the information in hand and requested them to remain present and act as witness if any search and seizure would have to be made upon which they agreed. At around 02.20 hrs we arrived at Chunavatti Raod in front of Tv center.

Thereafter, as pointed out by the source we noticed from a considerable distance that 14/1 persons assembled at Chunavatti Raod in front of Tv center and they were whispering in a very lov voice. We cordoned the place from every possible corner with due care and caution and approachin towards them very slowly and carefully but seeing the police personnel approaching towards ther they started to flee away from the spot but on hot chase we managed to apprehend above note three (03) accused persons and a Toto with out number plate while 12/13 others managed to fle away from the spot taking the advantage of open field and darkness. Thereafter, we disclosed or

identities as Police personnel (as we all were in civil dress for our convenience). On interrogation they disclosed their identities as noted above. On search One iron made sword approx length 37 inch with iron butt. (ii) One iron made Hanswa approx length 23 inch with butt. (iii) One iron road approx 2 (inch. (iii) One still colour iron made imitation fire arms measuring approx length 8 inch with handgrig and fitted with trigger from the possession of accused Saidul Islam. (iv) One red colour charger torch light (v) One black colour Mahindra E auto with out number plate with key. (vi) Four Android phone ir different company. On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with imitation fire arms, and deadly weapons in such dead hour of night. Finally they disclosed that they along with their associates assembled there and were making preparation for committing dacoity in Chunavatti Raod in front of Tv center.

Accordingly, I seized the above mentioned weapons of offence and other articles fron their possessions under proper seizure list in between 02.35 hrs to 02.55 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest observing all formalities of arrest. They are informed over the ground of their arrest. The whole process of search and seizure were made under the coverage of video graphy. Accordingly I brought all the 03 (three) arrested accused persons along with seized articles at NJP Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons, that they along with their associates assembled there and were making preparation for committing dacoity at Chunavatti Raod in front of Tv center and it surrounding area, they also confessed that they used the said imitation iron made fire arms with the intention to fear the common people in the time of commission of crime. Previously they used the said fire arms at the time of commission of crime.

From the above noted facts and seizure of incriminating articles there is strong reasons to believe that all the above noted 03 (three) accused persons along with others 12/13 other unknown accd, persons who fled away gathered there equipped with deadly weapons at such a dead hour conight for taking preparation to commit dacoity at Chunavatti Raod in front of Tv center.

Under the above circumstances, I pray before you that a specific case under prope sections of Law against may kindly be started against the above noted three (03) arrested accuse persons namely (i) Ronit Bhowmik (20) S/O Barun Bhowmik of Mother Teresa Road near payer cinema hall, PS Siliguri Dist Darjeeling (ii) Anisur Rahaman (190 s/o Mansur Alam of Tinbatti over bridge PS NJP Dist Jalpaiguri (iii) Saidul Islam (22) s/o Lt Sarat Ali of Tinbati over bridge, Jyotinmo Colony War No 32, PS NJP Dist Jalpaiguri and others 12/14 unknown miscreants and arrange for it investigation.
