Respected Sir,

In producing herewith 05 (five) arrested accused persons namely (i) Pramit Mandal (24) S/O Nitai Mandal of Ghogomali , Near Fulbazar, Ward No. 37 of SMC, P.S- Bhaktinagar , Dist.- Jalpaiguri, (ii) Rajkumar Mandal (25) S/O Mantu Mandal of Swaminagar Colony, Vivekananda Road, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling , (iii) Bikram Yadav (22) S/O Jhatha Shankar Yadav of Maharaj Colony, Ward No. 04 of SMC, P.S- Siliguri, Dist.- Darjeeling, (iv) Rajesh Mandal (33) S/O Lt. Mangal Mandal of Swaminagar Colony, Vivekananda Road, Ward No. 07 of SMC , P.S- Siliguri, Dist.- Darjeeling and (v) Md. Sahid (18) S/O Md. Hamid of Gawalapatty, Ward No. 04 of SMC, P.S- Siliguri, Dist.- Darjeeling along with the following seized articles under seizure as per seizure list :-

- (i) 01 (one) iron made sword measuring approx. 75 cm in length which is found on the right hand of the accused person named Pramit Mandal (24) S/O Nitai Mandal of Ghogomali , Near Fulbazar, Ward No. 37 of SMC, P.S- Bhaktinagar , Dist.- Jalpaiguri .
- (ii) 01 (one) iron made rod measuring approx. 70 cm in length which is found from the possession of the Rajkumar Mandal (25) S/O Mantu Mandal of Swaminagar Colony, Vivekananda Road, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling.
- (iii) 01 (one) iron made Sword measuring approx. 85 cm in length which is found on the right hand of the accused named Bikram Yadav (22) S/O Jhatha Shankar Yadav of Maharaj Colony, Ward No. 04 of SMC, P.S- Siliguri, Dist.- Darjeeling.
- (iv) 01 (one) iron made rod measuring approx. 90 cm in length which is found on the possession of accused named Rajesh Mandal (33) S/O Lt. Mangal Mandal of Swaminagar Colony, Vivekananda Road, Ward No. 07 of SMC , P.S- Siliguri, Dist.- Darjeeling.
- (v) 01 (one) iron made rod measuring approx. 85 cm in length which is found from the possession of Md. Sahid (18) S/O Md. Hamid of Gawalapatty, Ward No. 04 of SMC, P.S- Siliguri, Dist.- Darjeeling .

I ASI Kalachand Singha of Khalpara TOP-II under Siliguri PS, SPC do here by lodged this written complaint against the above noted accused persons and 05/06 others to the effect that on 14.05.2025 at 00.05 hrs., received a source information that 10/11 youth had assembled at Jhankar More, near Power House, Ward No 04 of SMC under Siliguri PS with a view to commit Dacoity in a house at Jhankar More adjacent areas. The fact has diarized in Khalpara TOP GDE No- 345 Dated-14.05.2025. Subsequently, after sharing the information with my superiors and as per their direction , at 00.15 hrs. myself along with force of Khalpara TOP left for Jhankar More, near Power House, Ward No 04 of SMC under Siliguri PS to work out the information along with investigation kit to verify the veracity of the information vide Khalpara TOP GDE No- 346 Dated- 14.05.2025.

On the way to Jhankar More, I contacted two independent witness namely (1) Bapi Roy (31) S/O Lt. Bikash Roy of Patiramjote, P.O+P.S- Matigara, Dist.- Darjeeling and make him aware about the information and requested him to act as witness, if any search and seizure would be made necessary upon which he agreed.

Thereafter, we along with the independent witness noted above reached at Jhankar More, near Power House, Ward No 04 of SMC under Siliguri PS under Siliguri PS at 00.40 hrs. and being pointed by the source cordoned off the suspected persons with strong reason to believe that they were preparing to commit some cognizable offence. Seeing police personnel they tried to fled away but on hot chase we managed to apprehend above noted 05(five) accused persons along with seized articles as mentioned above. However the other 5/6 persons manage to flee away from the spot taking the advantage of darkness. On interrogation the accused person admitted that they had assembled there to commit dacoity in a house at Jhankar More area under Siliguri Police Station.

I therefore, seized the above noted weapons under proper seizer list duly signed by the witnesses and acknowledged by the accused persons. The whole search and seizure was made in between 00.50 hrs. to 01.25 hrs. under proper videography. Thereafter I arrested the above noted accused persons under proper memo of arrest duly signed by the accused persons.

On further interrogation the arrested accused person stated that they were gathered there to commit dacoity in a house at Jhankar More area under Siliguri Police Station. It is also revealed from them that 5/6 other associates were manage to flee away from the spot taking the advantage of darkness.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused persons namely (i) Pramit Mandal (24) S/O Nitai Mandal of Ghogomali, Near Fulbazar, Ward No. 37 of SMC, P.S- Bhaktinagar, Dist.- Jalpaiguri, (ii) Rajkumar Mandal (25) S/O Mantu Mandal of Swaminagar Colony, Vivekananda Road, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling, (iii) Bikram Yadav (22) S/O Jhatha Shankar Yadav of Maharaj Colony, Ward No. 04 of SMC, P.S- Siliguri, Dist.- Darjeeling, (iv) Rajesh Mandal (33) S/O Lt. Mangal Mandal of Swaminagar Colony, Vivekananda Road, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling and (v) Md. Sahid (18) S/O Md. Hamid of Gawalapatty, Ward No. 04 of SMC, P.S- Siliguri, Dist.- Darjeeling and others and arrange for its investigation.
