In producing herewith three arrested accused persons namely (i) Raj Kumar Sahani (29 yrs) S/O Late Netlal Sahani of Mallaguri Tea Auction road, ward No. 46, PS- Pradhan Nagar, Dist- Darjeeling , (ii) Shusanta Sikdar (32 yrs) S/O Sri Megha Sikdar of Khudiram Colony, Baneswar more, PS- Bhaktinagar, Dist- Jalpaiguri and (iii) Bharati Mandal (F/35 yrs) W/O Sri Krishna Mandal of UmakantaTola, Mohodipur, PS- Kaliachak, Dist- Malda and the following seized articles viz.

- a) One transparent Zipper Plastic Pouch containing Total - 455 grams of suspected to be Brown Sugar - seized from the joint exclusive and conscious possession of the above noted three arrested accused person and marked as 'Exhibit- A'
- b) One Black colour Scooty (Ntoq-125 CC) bearing display Plate No. WB-74/BM-0184 and marked as 'Exhibit- B'

No. (e) was found from the exclusive and conscious possession of Bharati Mandal]

I, SI Pradip Singha of Siliguri PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted 03 (three) arrested lady accused persons namely ((i) Raj Kumar Sahani (29 yrs) S/O Late Netlal Sahani of Mallaguri Tea Auction road, ward No. 46, PS- Pradhan Nagar, Dist- Darjeeling , (ii) Shusanta Sikdar (32 yrs) S/O Sri Megha Sikdar of Khudiram Colony, Baneswar more, PS- Bhaktinagar, Dist- Jalpaiguri and (iii) Bharati Mandal (F/35 yrs) W/O Sri Krishna Mandal of UmakantaTola, Mohodipur, PS- Kaliachak, Dist- Malda (Not verified) to the effect that today

i.e on 14.05.2025 at about 07.05 hrs received a specific source information that 03 (three) persons including one lady person were coming from Biswas Colony under Matigara PS towards Tikiapara near Railwas Quarter, Ward No. 28 under Siliguri with possessing huge quantity of narcotic substances Brown Sugar to sell the same to their designed customers. The matter was diarized in Siliguri PS General Diary vide Siliguri PS GDE No.673 Dated- 14.05.2025 and subsequently, I informed the matter to the Inspector-in-Charge, Siliguri Police Station in written and being directed, myself along with SI Uday Chakraborty, ASI Subir Sen, ASI Debasish Das, ASI Rabin Lama, Const-160 Soumen Sarkar and LC/ 186 Anisha Biswakarma all of Siliguri PS, SPC and along with investigation kit left for Tikiapara near Railwas Quarter, Ward No. 28 under Siliguri PS by Govt. aided vehicle having Registration No-WB24K/7669, driven by CD-1148 Sudipta Nandi to verify the veracity of the source information. This refers to Siliguri PS GDE No.675 Dated- 14.05.2025 and M.C.C No- 421/2025 Date-14.05.2025. I also informed cameraman namely Ganesh Paswan (52 yrs) S/O Natthu Paswan of Swami Vivekananda Road near Madrasa School, Khalpara, Ward No. 08, P.S- Siliguri, Dist.- Darjeeling. Under this circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender.

On the way to Tikiapara near Railway Quarter under Siliguri Police Station, I contacted two persons namely (1) Md Samad Ali (23 yrs) S/O Md Samejul of Tikiapara, Pran Krishna Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling (8637044867) and (2) Md Altu (21 yrs) S/O Md Zuber of Tikiapara, Pran Krishna Colony, Ward No. 28, PS- Siliguri, Dist- Darjeeling (7584050633) and make them aware about the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter, we along with the independent witnesses & cameraman noted above reached at Tikiapara near Railway Quarter under PS Siliguri, Dist- Darjeeling at 07.35 hrs and being pointed by the source able to apprehend three persons along with one lady with the help of lady force who were sitting in the above noted Scooty at Tikiapara near Railway Quarter under PS Siliguri, Dist.- Darjeeling. Thereafter, we disclosed their identity and informed them regarding the information in hand and stated them that they will be searched in person for the said purpose. It is also found that one Shusanta Sikdar was driven the said Scooty and one female Bharati Mandal was sitting on just back side of Shusanta Sikdar as 1st Co-rider and rest of one person namely Raj kumar Sahani was sitting on back side of Bharati Mandal as 2nd Co-rider.

After disclosing our identities, in presence of independent witnesses we had a strong reason to believe that the detained persons were carrying narcotic drug in their exclusive joint possession & trying to supplying/ selling the same in the area for their wrongful gain. On being asked they disclosed their identity as noted above and admitted that they have illegally possessed Brown Sugar without any valid license for selling the same to their designed customers as per their requirement. I then gave them option in writing whether they wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer and they agreed to be searched in presence of any one of them. In the early morning, there are scare chance to contact any Executive Magistrate. No other alternative way, I informed the fact to Shri Prasenjit Biswas, Inspector -in-

charge, Siliguri Police Station to act as a Gazetted Officer regarding interception of the accused persons suspected to be possessed illegal Brown Sugar and requested him to come at Tikiapara near Railway Quarter, Ward No. 28 under Siliguri PS to remain present and to supervise the search and seizure as Gazetted Officer.

Accordingly, at 08.25 hrs Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer arrived in full uniform at the spot i.e Tikiapara near Railway Quarter, Ward No. 28 under Siliguri PS and introduced himself as Gazetted Officer. Then, I offered the independent witnesses and the accused persons to search our police party as per provision of law but they did not search the police party but as per instruction of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer personal search of our raiding party and our vehicles was conducted but nothing incriminating was found. A nil search list to that effect was prepared in-between 08.35 hrs and 08.45 hrs.

Thereafter in presence Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station (Gazetted Officer) and 02 (two) independent witnesses, I searched the detained persons including one lady person as noted above following all formalities, keeping their decency and recovered a) One transparent Zipper Plastic Pouch containing Total - 455 grams of suspected to be Brown Sugar - seized from joint the exclusive and conscious possession of the above noted arrested accused person and marked as 'Exhibit- A'

b) One Black colour Scooty (Ntoq-125 CC) bearing display Plate No. WB74/BM-0184 and marked as 'Exhibit- B'

c) One sky blue colour Oppo Mobile phone having IMEI 1:865768060680572 & IMEI 2: 865768060680564 seized from the possession of accused person namely Raj Kumar Sahani, marked as Exhibits -"C"

d) One Black blue colour Vivo mobile phone having IMEI 1: 864562070571017 & IMEI 2 :864562070571009 from the possession of Shusanta Sikdar, marked as exhibits-D,

e) One Black blue colour Vivo mobile phone having IMEI 1: 868409048481364 & IMEI-2-864809048481356 from the possession of Bharati Mandal, marked as exhibits-E, f) Cash Rs.30,000/- (Thirty thousand rupees) denomination Rs.100x300 = Rs.30,000/- , Marked as Exhibits-F [Articles noted in Sl. No. (a) & (f) found inside (Diggi) in Sl. No.

(b) were seized from the joint exclusive and conscious possession of the above noted three arrested accused persons and Sl. No. (c) was found from the exclusive and conscious possession of Raj Kumar Sahani, Sl. No. (d) was found from the exclusive and conscious possession of Shusanta Sikdar, and Sl. No. (e) was found from the exclusive and conscious possession of Bharati Mandal]

Further, on demand in presence of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer as well as independent witnesses the above noted detained persons failed to produce any valid documents in support of possessing of such contraband.

Being further interrogation, all the above noted accused persons admitted in presence of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station, acting as Gazetted Officer and the independent witnesses that they have procured the above noted illegal Brown Sugar clandestinely for the purpose of selling the same in high rate to their designed customers for their personal gain by illegal means. They also disclosed that they have been dealing in this business of procuring and selling of Brown Sugar illegally for last few months for their wrongful gain.

Accordingly, I seized the above noted articles from the exclusive and conscious possession of the above noted accused persons at the spot at Tikiapara near Railway Quarter, Ward No. 28 under Siliguri Police Station Dist- Darjeeling under proper seizure list in presence of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer as well as independent witnesses as noted above. Subsequently, I labelled the seized articles in presence of Shri Prasenjit Biswas, Inspector -in-charge, Siliguri Police Station acting as Gazetted Officer and independent witnesses as noted above. The whole process of seizure and label was made in between 09.10 hrs to 10.35 hrs on 14.05.2025. The whole process of Search seizure is under video graphed.

From the above noted facts and seizure of incriminating articles it is quite evident that the above noted accused person including one lady accused persons namely (i) Raj Kumar Sahani (29 yrs) S/O Late Netlal Sahani of Mallaguri Tea Auction road , ward No. 46, PS- Pradhan Nagar, Dist- Darjeeling , (ii) Shusanta Sikdar (32 yrs) S/O Sri Megha Sikdar of Khudiram Colony, Baneswar more, PS- Bhaktinagar, Dist- Jalpaiguri and (iii) Bharati Mandal (F/35 yrs) W/O Sri Krishna Mandal of UmakantaTola, Mohodipur, PS- Kaliachak, Dist- Malda (Not verified) are involved in procuring and selling of Brown Sugar illegally contravening the norms of NDPS Act. Then, I arrested the above noted accused person including one lady accused person with the help of lady force after observing all the formalities and informing the ground of their arrest and issued necessary Memo of arrest.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused persons (i) Raj Kumar Sahani (29 yrs) S/O Late Netlal Sahani of Mallaguri Tea Auction road , ward No. 46, PS- Pradhan Nagar, Dist- Darjeeling , (ii) Shusanta Sikdar (32 yrs) S/O Sri Megha Sikdar of Khudiram Colony , Baneswar more, PS- Bhaktinagar, Dist- Jalpaiguri and (iii) Bharati Mandal (F/35 yrs) W/O Sri Krishna Mandal of UmakantaTola, Mohodipur, PS- Kaliachak, Dist- Malda (Not verified) and arrange for its investigation.
