I, Sarina Chhetri, Daughter of Late Pran Chhetri, Wife of Sri Mihir Anand, resident of 1B Radha Apartment, Gandhi Nagar, Lower Bhanu Nagar, Ward No.43 of Siliguri Municipal Corporation, Siliguri, Post Office- Sevoke Road, Police Station- Bhaktinagar, District-Jalpaiguri, PIN-734001 lodge this complaint against my mother Smt Durga Chhetri, Wife of Late Pran Chhetri; my two sisters namely Sabina Chhetri alias Sabina Mondal (Mobile:9136897343), Daughter of Late Pran Chhetri, Wife of Late Rajiv Mondal; Subani Chhetri (Mobile:9933182752 / 8820590215), Wife of Sri Suraj Chhetri, Daughter of Late Pran Chhetri; Santa Chhetri, Wife of Dharmendra Chhetri; Karan (Mobile-9903231420) who drives a battery operated toto and the person who helped who make duplicate keys.

The case in a gist is that I am the owner of a G+2 storied building (except a flat therein) situated at Near Radha Krishna Complex, Shashtri Nagar, Ward No. 41 of Siliguri Municipal Corporation, Sevoke Road, Siliguri, Post Office- Sevoke Road, Police Station- Bhaktinagar, District-Jalpaiguri, PIN-734001. All other flats in the said building which belong to me are given on rent by me. One flat in the said building which was in my possession has been temporarily handed over to my mother by me for her residence after my father's death on 04.01.2025. Today at around 6.30 pm when I went to said house and opened my almirah I found that my following articles are missing from my almirah:

- 1. My documents which includes my IT return file, my persona banking documents.
- My jewellery which includes a gold chain with pendent, one pair diamond earings which was gifted to me by my motherin-law, 4 gold child bangles, One pair gold Pola Bangles.

Immediately thereafter I asked my sisters about the theft but both kept silent over the issue. Thereafter I checked my CCTV footage wherein I learnt that on 06.05.2025 my mother Smt Durga Chhetri; my two sisters namely Sabina Chhetri alias Sabina Mondal; Subani Chhetri; Santa Chhetri, Wife of Dharmendra Chhetri have contacted a person named Karan (Mobile-9903231420) who drives a battery operated toto and with the aid and assistance of Karan they have arranged for a person who makes duplicate keys and with the help of duplicate keys have broke opened the almirah and stolen my goods.

This act of theft was done without my permission or knowledge, and the use of duplicate keys and unauthorized access to the premises makes this a clear case of theft and criminal trespass. If the toto driver is questioned thoroughly, the true facts would be revealed.

Furthermore Smt Durga Chhetri; my two sisters namely Sabina Chhetri alias Sabina Mondal; Subani Chhetri have forcefully been collecting the rent from my tenants by blackmailing them and also misappropriating the same for their personal gain.

I kindly request you to take immediate action by registering this complaint as an FIR in accordance with the appropriate provisions of criminal law, investigating the matter thoroughly, identifying the unknown individual involved, and recovering the stolen items.
