Respected Sir,

With due respect I Sumitra Sarkar
D/o of Late Biren Sarkar residing in Sarojini Pally
Ward No. 42 in Siliguri want to draw your kind attention
towards my problem. On 11th December 2019 I got married
with Dipak Guha residing in Kolkata who was working
at Sattok Ashram. Since the day of marriage I stayed
along with my husband in my mother's home as my mother
has no one except me to look after her. Before marriage
I and my mother was leading very helpless life surrounded
by many problems, my husband took the advantage
and had married me hiding many things about him
which was discovered after marriage. From that very
moment he began to mentally torture me and also was
not giving me adequate expenses to run the household.
After one year of my daughter's birth he was always
blackmailing me to take away my daughter from me
if I will not sell my mother's land and go with
him anywhere else. When my daughter was 2½ years
old I started teaching in one private school to meet
my household expenses as my husband told me to earn
my living by my own. On 10th April 2024 I met a serious

road accident injuring my right leg very badly. From that time onwards we are staying separate and he is also not giving me any expenses and I was also not asking from him. But then also he often used to come and was saying bitter words and warning to take away my daughter from me. He also warned to take legal action against me and put me behind the bars. But yesterday (12.5.2023) he came to our house and took my daughter forcefully outside the house and my daughter began to cry. When I went to take her back, he started beating me very badly. Seeing this my mother went there and tried to stop him, but he pushed my mother and she fell down on the road and got scratches on her leg and elbow. Then the neighbours around my house came on the spot and stopped him. He went away from there by giving warning that he will again come and take away my daughter from me.

So, I kindly request you to help me and my mother and daughter to remain safely and peacefully.

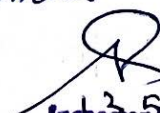
