With due respect I smt. Sonali Sha w/o Aniket Sha residing at Sastri Nagar, near dr. Rajendra Prasad Road, Iskon Vatika Road, word no -41, P.O. Sevok road ,P.S. -Bhaktinagar , Dist-Jalpaiguri would like to draw your kind attention on the following effect that yesterday night at about 11.00 P.M. suddenly my husband hear shouting outside then he went out and saw that the above named accused persons who are the uncle of my husband brutally beat his another uncle namely Ajit Sha, and when my husband try to rescue his uncle they without any reason started using filthy languages upon my husband and when my husband defend him the above mentioned accused persons without any reason beat my husband here and there, finding no other alternative my husband fled away and came to our house, but the above mentioned accused run after my husband and without any permission enter our room, where I was laying on my bed with my 26 days new born child as because 26 days ago I have surgery , the above mentioned accused no .2 suddenly kick on my belly and torn my wearing apparel, and the accused no 1 also beat me here and there, soon after this incidents I became unconscious and blood also came out from my seizure, not only that accused no. 2 come out a sharp weapon and try to kill my new born child, finding no other alternative when I started shouting the above mentioned accused persons fled away. Then with the help of the local people and my husband they took me and ajit Sha to the Siliguri District Hospital where our treatment is going on.

I also mentioned here that the above mentioned accused no.2 is a habitual drinker and was in a rehab center. Few days ago he came from there, not only that many time he created nuisance with other members of the locality.

Therefore I request you please look into this matter as soon as possible and take legal action this illegal activities as because I am very much afraid that they can kill my child anytime.
