Sir,

In producing herewith, the 02 (Two) arrested accused person named 1) Safu Sk (38) s/o Matlu Sk of Mandai TAI Mandal Para, PS- Baishnab Nagar, Dist.- Malda....2) Aktar Sk (27) s/o Rasiuddin Sk of Mandai PS- Baishnab Nagar, Dist.- Malda along with the following seized articles under proper seizure list: -

- (1) Total cash of Indian Currency of Rs.- 1,58,500/- = Rs.- 500 X 200 = 1,00,000/- , Rs.- 200 X 195 = 39,000/- and Rs.- 100 X 195 = 19,500/-
- 2) One Plastic Packet said to be Brawn Sugar Weighting approx.- 660 gms. Marked as Exhibit A,
- 3) One Red and Black Colour Pulser 180CC bearing Reg. No.- WB-74BJ-0073 with Key.
- 4) One android oppo F-29 5G with SIM.
- 5) One black colour sling bag having label pointo Lithium Batteries containing Seizure S.I No.- 1 and 2 from the procession of Safu Sk (38) s/o Matlu Sk and
- 6) One Plastic Packet said to be Brawn Sugar Weighting approx.- 885 gms. Marked as Exhibit B,
- 7) One android Mobile Phone Realme with SIM,
- 3) One black and blue Strip Back Pak having label LIBYA containing seizure no 7) & 8) from the procession of Aktar Sk s/o Rasiuddin Sk .

I, SI Samik Paul of New Jalpaiguri Police station, Siliguri Police Commissionerate do here by lodge this written complaint against above noted 02 (Two) arrested accused persons to the effect that on 13.05.2025 at about 21:35hrs, I received a specific source input that two persons coming from matigara side towards Fulbari area with one motor cycle having registration No.- WB-74BJ-0073 with huge consignment of suspected to be Brown Sugar for their clandestine disposal. The matter was diarized vide NJP PSGDE No 821 Dt. 13.05.2025 and I informed the matter to I/C NJP PS and expressed the entire information. As per his kind direction myself along with other officers and force named SI Tanmay Kundu, ASI Nilam Swarnakar, , C/1462 Sajan Tamang VP 08 Laxman Roy, VP 13 Jamirul Islam all of NJP PS, Siliguri Police Commissionerate being headed by me left for Biswabanga Silpi Hutt, under New Jalpaiguri PS, Dist.- Jalpaiguri by govt. vehicle with investigation kit to verify the veracity of the information in hand vide NJP PS GDE No 822, Dated- 13.05.2025 and M.C.C. No. 597/25, Dated-13.05.2025. I also informed the Videographer namely Tapan Manda, S/o-Tusto Mandal of Bhola More, PS- NJP, Dist.- Jalpaiguri to be present at Biswabanga Silpi Hutt, under New Jalpaiguri PS, Dist.- Jalpaiguri to prepare the Video of whole process of search and seizure if any. Under these circumstances any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidences of facility for the escape of the offender.

On the way to Biswabanga Silpi Hutt, I, called two independent witnesses namely (i) Subrata Mandal(30) s/o Dayal Mandal of Porajhar PS New Jalpaiguri Dist Jalpaiguri (ii) Samir Majumdar (31) s/o Haripada Majumdar of Porajhar PS New Jalpaiguri Dist Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them to accompany us and remain present in the whole process during search and seizure if necessary with a written letter and necessary permission of their presence and act as independent witnesses under relevant provision of law.

At about 22.05 I along with the other officer and force and the witnesses are reached at Biswabanga Silpi Hutt, after some time being pointed by my source, we saw one motor cycle having no WB-74BJ-0073 coming from Matigara side towards Noukaghat. after seeing police party they try to fled away but somehow we managed to intercept the the said motor cycle and apprehended the rider & Pillion rider of the motor cycle who disclosed their identity as noted above.

After disclosing our identity, we detained the above noted persons with a strong reason to believe that they illegally possessing suspected to be Brown sugar. On being asked they confessed their guilt and admitted that they were carrying the suspected to be Brown Sugar for the purpose of selling the same to their designated customers in order to earn huge money illegally for their wrong full gain. Then I gave them option in writing whether they wanted to be searched in presence of Executive Magistrate or by any Gazetted Officer. The apprehended persons agreed to be searched by Gazzeted Officer. I also offered the apprehended persons to search our Police Party as per provision of law but they denied to search police party.

Accordingly, at about 22:36 hrs I informed the matter to Gazated officer Shri Sonam Lama, Inspector-In-Charge, New Jalpaiguri PS, SPC and requested him to come to the spot and to supervise the whole search and seizure being a gazette officer. Accordingly, at 22.55 hrs. Shri Sonam Lama, Inspector-In-Charge, New Jalpaiguri PS, SPC arrived at the spot and accordingly, I disclosed his identity to the detained persons as Gazated officer. Then In presence of Shri Sonam Lama, Inspector-In-Charge, New Jalpaiguri PS, SPC and other two independent public witnesses we searched the detained persons and from the rider of the apprehended motor cycle I found one black colour sling bag having label Pointo Lithium Batteries, after open the said bag I found 1) Total cash of Indian Currency of Rs.- 1,58,500/- = Rs.- 500 X 200 = 1,00,000/- , Rs.- 200 X 195 = 39,000/- and Rs.- 100 X 195 = 19,500/- 2) One Plastic Packet said to be Brawn Sugar 3) One android oppo F-29 5G with SIM And from the black and blue Strip Back Pak of the pillion rider having label LIBYA I found 1)One Plastic Packet said to be Brawn Sugar 2) One android Mobile Phone Realme with SIM. On demand in presence of Shri Sonam Lama, I/C NJP PS they failed to produce any valid document in support of possessing of the suspect to be Brown Sugar and also the said Rupees which they were carrying. After weighing, it was found that the Plastic Packet said to be Brawn Sugar which was found inside the sling bag of Safu Sk is Weighting approx.- 660 gms and one plastic packet said to be brown sugar which was found from the back pack of Aktar Sk Weighting approx.- 885 gms (Total 1545 grams suspected to be Brown Sugar). Accordingly, I seized the two plastic packet containing

885 gram and 660 gram suspected to be Brown Sugar, and the others recover item and also the said motor cycle having registration no WB-74BJ-0073 74 from the procession of the above noted two accused person namely Safu Sk 2) Aktar Sk. In presence of gazetted officer Shri Sonam Lama, I/C New Jalpaiguri PS/SPC nad other eye witnesses. Then I sealed the said 660 gram said to be brown sugar in an envelope and marked as "Exhibit A" and another 885 gram said to be brown sugar in a envelope and marked as "Exhibit B" in an envelope,. The whole process of seizure and label is made in presence of I/C NJP PS Shri sonam lama and other two witness and dully acknowledge by the accused person. The whole process of seizure was made in between 23:05 hrs to 23:40 hrs under proper video graphy.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons Safu Sk (38) s/o Matlu Sk of Mandai TAI Mandal Para, PS- Baishnab Nagar, Dist.- Malda....2) Aktar Sk (27) s/o Rasiuddin Sk of Mandai PS- Baishnab Nagar, Dist.- Malda (Not verified) are involved in procuring and selling of Brown Sugar illegally and contravening the norms of NDPS Act was established. Then, I arrested the above noted accused persons after observing all guidelines of Apex court of arrest as well as after disclosing the cause of arrest and issued necessary Memo of Arrest.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the arrested accused persons named Safu Sk (38) s/o Matlu Sk of Mandai TAI Mandal Para, PS- Baishnab Nagar, Dist.- Malda....2) Aktar Sk (27) s/o Rasiuddin Sk of Mandai PS- Baishnab Nagar, Dist.- Malda (Not verified) and others and arrange for its investigation.
