Sub: FIR for Illegal encroachment of land and demolition of structures

Respected Sir,

I, Sri Ajmer Singh, S/o Late Harchand Singh, residing at Kartar Garage, Opposite Terai Lions Blood Bank, Jyotinagar, P.S. Bhaktinagar, Siliguri, Dist. Jalpaiguri, in the state of West Bengal would like to lodge a formal complaint regarding a serious and unlawful incident of land encroachment and destruction of a wall at my property

The details of the incident are mentioned below:

1. On 11th May, 2025, the local people informed me regarding the demolition of a wall at my aforesaid land by some unknown persons.
2. That the location of the land is situated at L.R. Plot No.: 224, L.R. Khatian No.: 610 & 743, Mouza – Binnaguri, Sheet No. 13, Fulbari II Gram Panchayat, P. S. NJP, Dist. Jalpaiguri
3. Nature of Offence: On the aforementioned date i.e. 11th May, 2025, several unidentified persons, unlawfully entered the above mentioned land without any legal right, authority or permission. They encroached upon the property and proceeded to demolish the existing wall on the land, which includes the middle wall. This act was carried out forcibly and in blatant disregard of the law.
4. That the said land is legally owned/ possessed by me and I possess all valid documents and titles to substantiate my claim. Copies of these documents can be furnished if asked/required.
5. That the legal demolition has caused significant financial loss and emotional distress.
