I, ^{wife} PINKI BISWAS, son of Sri. Sushanta Biswas, permanent resident of Vill. Kawakhali, P.O. Sushrutanagar, P.S. Matigara, Dist. Darjeeling, would like to inform you that as follows:-

1. That I am a legally married wife of Sri. Sushanta Biswas, son of Sri. Subodh Biswas. Since my marriage I am residing with my husband and alongwith my father-in-law namely SUBODH BISWAS, son of Late Rajendra Biswas, mother-in-law SMT. AYNABISWAS, wife of Sri. Sushanta Biswas, younger brother-in-law SRI. TAPASH BISWAS, son of Sri. Subhash Biswas, and younger Sister-in-law SMT. BOBITA BISWAS @ MOUSUMI BISWAS, wife of Sri. Subhash Biswas, at my above mentioned residence. Out of our wed-lock one male child namely Subho Biswas (aged about 11 years) and one Female child namely Disha Biswas (aged about 3 years) took birth. Ever since our marriage all my above named In-laws always tortures me both physically and mentally which gradually increased day by day. My husband on several occasions requested my all the above named In-laws not to torture me and my children but in vain. In fact my above named in-laws have been trying to evade me, my husband and my children from his own house so that my in-laws could totally occupy my husband's possession in land.

That yesterday on 14.05.2025 at about 2.30 P.M. when my husband was installing bamboos for installing plastic shed for the protection of our yard suddenly my all the above named in-laws became furious and without saying anything started to assault me and my husband brutally with fist, kicks, blows and also with sticks and bamboos by uttering "TODAY YOU BOTH WILL NOT REMAIN ALIVE". In fact my In-laws tore my clothes in front of my children and all of them tried to forcefully push us out from our house. When the above incidents was going on one MOHAN MONDAL son of "Unknown" and another BHUBANESHWAR SAHANI, son of "unknown" suddenly entered in my house and said BHUBANESHWAR SAHANI assaulted my husband with fists, kick and blows and as a result my husband fell on the yard and became senseless. While I was doing videography through my mobile phone of this incident said MOHAN MONDDAL snatched my mobile but later returned it to me. All the above named In-laws threatened us that if we do not leave their house today then they will kill us all and after seeing this my In-laws went back to their rooms. Later, when my husband regained consciousness I took my husband in NBMC & H for his treatment. At present my husband is admitted to the NBMC & H and is under treatment.

15.5.25 I therefore request you to kindly take necessary legal steps against the aforesaid 1. SUBODH BISWAS, 2. AYNABISWAS, 3. TAPASH BISWAS, 4. BOBITA BISWAS @ MOUSUMI BISWAS, 5. MOHAN MONDAL and 6. BHUBANESHWAR SAHANI. I shall be highly obliged to you forever.
