Dear Sir,

I am Prashant Rai inform you that, I formally lodge a complaint regarding multiple incidents of harassment, racial discrimination and threats of physical violence that I have experienced.

Today (15/05/25) my younger brother was doing his own work on early morning. Sanjay my nearby shop owner fully blocked walk path (footpath) by their cycle and a small tea stall. we talked about that and Sanjay started a violence and pushing away my younger brother and uses a verbal slang words against us. He also tried to hit us with wooden battan.

And also we have been subjected to racially discriminatory comments and behaviours. including abusing our parents.

These action were not only offensive but also deeply distressing and inappropriate in any profession or public sitting area.

on 15/05/25 Sanjay Gupta made a direct threat of physical harm towards us. This is not

a first time he regularly abuse and giving threats to us, he always use to say that he will drive away us from here.

There fore many time his staff stealing our gas cylinder, some kitchen utensils. also a money. we are already informed our shop owner

Impact:-

These incidents have significantly affected my mental health and my ability to feel safe and respected in this environment

Please treat this matter with urgency and confidently.
