Sir,

With due respect and humble submission I, ASI Utpal Das of Bhorer Alo P.S, SPC would like to lodge this written complaint against the arrested accused person namely Dhirman Roy (M/37 Yrs) S/o- Kupon Roy of Cheulibari, P.O- Kundar Dighi, PS- Rajganj, Dist- Jalpaiguri, after producing the following seized articles with proper seizure list viz:

(i) Eighteen (18) sealed Bottles of "BAZIGAR" 70 UP INDIA MADE LIQUOR each bottle containing 300ml [Total 18 X 300 ml = 5.400 Litres], Rs 40/-each (Amounting of Rs. 40/- X 18 =Rs 720/-) marked as "Exhibit-A" out of which one bottle is taken as sample and marked as "Exhibit-A1", to the effect that today on 16.05.2025 at about 09:00 hrs myself along with force while performing my PC mobile Van duty under Bhorer Alo Police Station vide Bhorer Alo PS GDE No. 594 Dated 16.05.2025 during PC Mobile van duty when we reached at Paramunda More under Bhorer Alo PS at that time found one person carrying huge quantity of illicit liquor on a nylon bag. Accordingly we apprehended him and on interrogation he stated that the above noted illicit liquor to sell the same at Bhorer Alo PS area.

On further interrogation he stated that he used to sale the 70 up "BAZIGAR" to the owners at different areas under Bhorer Alo Police Station without any valid documents as he violated the norms of Bengal Excise Act for selling the said Liquor without any valid License. On search Eighteen (18) sealed Bottles of "BAZIGAR" 70 UP INDIA MADE LIQUOR each bottle containing 300ml @ Rs 40/- each (Amounting of Rs. 40/- X18 =Rs 720/-) was kept at nylon bag which he was carrying. On being interrogation he disclosed his name & identity as Dhirman Roy (M/37 Yrs) S/o- Kupon Roy of Cheulibari, P.O- Kundar Dighi, PS- Rajganj, Dist- Jalpaiguri and on further enquiry it could be learnt that he has been involved in selling and possessing of illicit liquor without any valid license since few months for his wrongful gain. The said accused person namely Dhirman Roy has violated the norms of Bengal Excise Act. Accordingly Then I, seized and labeled the above mentioned articles under proper seizure list in presence of witnesses and subsequently arrested the above mentioned person namely Dhirman Roy after observing all the formalities. The whole process of seizure and label has been made in between 09.25 hrs to 09.33 hrs.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused namely Dhirman Roy (M/37 Yrs) S/o- Kupon Roy of Cheulibari, P.O- Kundar Dighi, PS- Rajganj, Dist- Jalpaiguri along with seized articles under proper section of law and arrange for its investigation.
