In producing here with the seized articles viz:-

1) 05(five) Nos. of Indane Domestic gas cylinder in which (01 fully loaded, 02 Partial loaded, 02 Empty).

Under proper seizure list. I Inspector SK Rahetaje Noor Nabi of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge a written complaint against Arjun Roy (32) S/O Lt. Bisha Roy of Baghajotin Park, W/No 17, PS- Siliguri, Dist- Darjeeling of "Aapki Pasand Restaurant" (Biriyan Shop) located at Bagajatin Park road W/No 17, PS- Siliguri, Dist- Darjeeling who was illegally procured the domestic Gas cylinder at his Restaurant styled as "Aapki Pasand Restaurant" for commercial purpose without any valid documents or license to the effect that today i.e. 16.05.25 at about 12:45 hrs vide Enforcement Branch SPC, GDE No. 91 Dt. 16. 05.2025 in course of joint inspection with Food & Safety Department and Other Officials (A team formed vide Memo No 87/SMC/G Dtd. 13.05.2025 of Siliguri Municipal Corporation) arrived at above noted Restaurant styled as "Aapki Pasand Restaurant" situated at above mentioned address and found using the domestic Gas cylinder at his Restaurant for preparing food items for using commercial purpose for his wrongful gain.

Hence I informed the matter to ACP EB, SPC and as per his instruction I along with officers and force conducted raid in the restaurant run by Arjun Roy (32) S/O Lt. Bisha Roy of Baghajotin Park, W/No 17, PS- Siliguri, Dist- Darjeeling. During search found worker of Restaurant making food items by using the domestic Indane gas cylinder without any valid documents for commercial purpose, On demand they failed to produce any valid documents in support of using the Indane domestic gas cylinders in Restaurant styled as "Aapki Pasand Restaurant" for commercial purpose.

It is crystal clear that the said person namely Arjun Roy (32) S/O Lt. Bisha Roy of Baghajotin Park, W/No 17, PS- Siliguri, Dist- Darjeeling is using the Domestic gas cylinders in his Restaurant for his wrongful gain. As per local enquiry it came to light that the above noted person storing and using gas negligently with respect to fire or combustible matter, which may endanger human life or likely to cause hurt or injury to person at that locality area. Arjun Roy does not have any valid Documents regarding above seized articles. Thus the above noted accused person violated the provision of West Bengal Cooking Gas (License and Control) order 1985 and other Government Orders.

Accordingly I seized the above noted seized articles as per seizure list in presence of local witnesses namely 1) Suresh Das (Worker) and 2) Sukumar Das (Worker) both S/O Lt. Aswini Das of Lichubagan, Subashpally, W/no 18, PS- Siliguri, Dist Darjeeling. The seizure was made in between 13:15 hrs to 13:35 hrs.

Hence, I pray that a specific case may be recorded against the accused person namely Arjun Roy (32) S/O Lt. Bisha Roy of Baghajotin Park, W/No 17, PS- Siliguri, Dist- Darjeeling U/S 287/3(5) BNS R/W Sec 7(1)(a)(b)(c) of EC Act 1955 and other appropriate sections of law.
