Sir,

In producing herewith one arrested person who disclosed his identities namely Raja Das (22 yrs) S/O Sri Shibu Das of Nichpara, Deshbandhupara, ward No. 30, PS- Siliguri, Dist- Darjeeling along with the seized articles as per seizure list;

(1) One improvised one shutter iron made fire arms with wooden butt measuring approx 10.5 inches from barrel to butt having striking pin, hammer and trigger marked as Exhibits- 'A'

(2) One live ammunition engraved O.K 03 unreadable on its percussion cap (found loaded in SI No.1 ) seized from exclusive and conscious possession of accused Raja Das marked as Exhibits- 'A1'

(3) One live ammunition engraved O.K 7Z unreadable on its percussion cap (which was kept concealed in the right pocket of black colour track pant of accused Raja Das) seized from exclusive and conscious possession of accused Raja Das marked as Exhibits-A2

I, Uday Chakraborty of Siliguri Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against Raja Das (22 yrs) S/O Sri Shibu Das of Nichpara, Deshbandhupara, ward No. 30, PS- Siliguri, Dist- Darjeeling that on 16.05.25 around 20.05 hrs, received a secret source information that one veteran criminal under Siliguri PS, Dist- Darjeeling namely Raja Das is roaming at Jorapani bridge, Bharat Nagar, Ward No, 24 under Siliguri PS with an ulterior motive and is in possession of firearms. Diarised the mater vide Siliguri PS GD Entry No. 881 dated 16.05.25. As per your kind instruction of I/C Siliguri PS, I along with ASI Subir Sen, ASI Rabin Lama, C/160 Soumen Sarkar all Siliguri PS rushed to the place at Jorapani bridge, Bharat Nagar, Ward No, 24 under Siliguri PS to verify the veracity of this information vide Siliguri PS G.D.E no.882 dated 16.05.2025 at 20.15 hrs. Before reaching PO I picked up two disinterested witnesses namely (i) Tamal Sutradhar (36 yrs) S/O Sri Dulal Sutradhar of South Bharat Nagar, Jorapani Bridge, Ward No. 24, PS- Siliguri, Dist- Darjeeling and (ii) Swapan Kr. Goswami (46 yrs) S/O Late Shankar Goswami of Hatiadanga near Hatidanga Junior School, PS-Bhaktinagar, Dist- Jalpaiguri duly informing them about the information in hand. At 20.25 hrs we reached at nearby Jorapani bridge, Bharat nagar, Ward No, 24 under Siliguri PS and as per description of the wearing apparels supplied by the source, at 20.35 hrs we found that the above noted person is moving suspiciously at Jorapani bridge, Bharat nagar, Ward No, 24 under Siliguri PS. On seeing the police party he tried to escape from the place. But we apprehended the above noted person namely Raja Das. On being asked, the apprehended person disclosed his identity as noted above. On further interrogation he admitted that he was in the Jorapani bridge, Bharat Nagar, Ward No, 24 under Siliguri PS with an ulterior motive with illegal Fire Arms. Accordingly, as per information and following all necessary procedures of search of the police person by the witnesses, search of the apprehended person Raja Das was made on search and found that (1) One improvised one shutter iron made fire arms

with wooden butt measuring approx 10.5 inches from barrel to butt having striking pin, hammer and trigger marked as Exhibits- 'A' which was kept concealed under the black Colour Track on the right side of the above noted accused person's waist, (2) One live ammunition engraved O.K 03 unreadable on its percussion cap (found loaded in SI No.1 ) seized exclusively from possession of accused Raja Das marked as Exhibits- 'A1', (3) One live ammunition engraved O.K 7Z unreadable on its percussion cap (which was kept concealed in the right pocket of black colour track pant of accused Raja Das) seized exclusively from possession of accused Raja Das marked as Exhibits-A2. The ammunition was unloaded from the firearms as per practical experience. On being asked about the possession of the firearms and ammunition, the apprehended Raja Das made incoherent statements and failed to produce any valid documents in support of said seized Firearms. As there is every reason to believe that the firearms and ammunitions recovered has been procured dishonestly by the apprehended Raja Das for his ulterior motive, seized and labelled the firearms and ammunition duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledge by the apprehended person and arrested him following all formalities. The seizure and label was made in-between 20.35 hrs and 21.35 hrs. On being further asked the arrested accused person admitted that he used purchased the same from Bihar state and sold the same to his design customer for his wrongful gain.

Under the above circumstances, I pray that a specific case under Arms Act may kindly be started against the arrested Raja Das (22 yrs) S/O Sri Shibu Das of Nichpara, Deshbandhupara, ward No. 30, PS- Siliguri, Dist- Darjeeling and arrange for its investigation.
