In producing herewith one arrested accused person namely Shambhu Sahay (52 yrs) S/O Lt. Kashinath Sahay of Hakimpara near T.S.Club, W/No. 15, PS-Siliguri, Dist.-Darjeeling along with following seized articles viz. (1) 10 (Ten) sealed Bottles of Humalayan Tuk Tuk PET 80° UP Country made liquor containing 600 ml. each (2) 01 (One) Nylon Bag which were used

for carrying the seized articles noted in Sl. No- 1. I, ASI. Surojit Mallick of Panitanki TOP under Siliguri PS, SPC hereby lodge this written complaint against the above noted accused person to the effect that on 16.05.2025 at 20.05 hrs I have received secret source information that one person is carrying huge quantity of country spirit bottles in a Nylon bag with him and approaching through Bidhan Road towards Panitanki More. Accordingly informed the same to O.C Panitanki TOP and diarized the matter at Panitanki TOP vide Panitanki TOP GDE No. 364, dated 16.05.2025 and thereafter as per his direction I along with mobile van officer ASI. Ratan Kr. Ghosh, C/114 Naresh Hasda and C/739 Dilip Mitra left for Bidhan road to work out the veracity of information. On arrival near Dolly Inn Hotel, Bidhan Road, Siliguri at 20.35 hrs we are searching for that person. After sometimes being pointed out by the source, we found that one person was proceeding with huge quantity of country spirit carrying in a Nylon bag. Accordingly I have intercepted & apprehended him. Then I searched him in presence of two indepeddent witnesses named (i) Rakesh Kurmi S/O Lt. Ramesh Kurmi resided near Kanchanjungha Lodge, Bidhan Road, W/o. 11, Ps-Siliguri, Dist.-Darjeeling & (ii) Manish Singh S/O Lt. Nirmal Singh of Pradhan More, W/No. 40, PS-Bhaktinagar, Dist-Jalpaiguri and recovered 10 (Ten) sealed Bottles of Himalayan Tuk Tuk PET 80° UP Country made liquor containing 600 ml. each. During interrogation the accused failed to produce any documents/license in support of the same and stated that he sells the same illegally to the local public for his wrongful gain and daily livelihood. Accordingly I seized the said (i) 10 (Ten) sealed Bottles of Himalayan Tuk Tuk PET 80° UP Country made liquor containing 600 ml. each (ii) 01 (One) Nylon Bag which was used for carrying the seized articles noted in Sl. No- 1 under proper seizure list and labeled the same in presence of witnesses and took their signature in seizure list and it is also signed by the accused person. The seizure was made in between 21.21 hrs and 21.30 hrs. I then arrested the accused person u/s 35(1) BNSS after explaining charges & ground of arrest to him. Total value of seized articles is Rs. 600/-.

Hence, under the above noted circumstances I am submitting this written complaint against the accused person Shambhu Sahay (52 yrs) S/O Lt. Kashinath Sahay of Hakimpara near T.S.Club, W/No. 15, PS-Siliguri, Dist.-Darjeeling to initiate a specific case under proper section of Law and to arrange for its investigation.
