Subject :- F.I.R.

Sir,

With due respect, I am producing herewith the following seized articles viz :- (i) one paper made cartoon containing 12 (twelve) bottles of of "TUBORG" Premium Beer each bottle containing 650ml. i.e total (12 X 650ml. = 7.8 ltrs, marked as Exhibit "A" out of which one bottle of the same taken as sample for examination and marked as Exhibit-"A1" and ii) 09 (nine) bottles of 60 UP "HIMALAYAN GOLD" India made liquor each bottle containing 600ml. i.e total (09X600ml= 5.4 ltrs) marked as Exhibit- "B" out of which one bottle of the same taken as sample for examination and marked as Exhibit- "B1".

I ASI Biplab Kumar Das of Pradhan Nagar PS, SPC do hereby lodged this written complaint against the owner of Hotel Vishal situated at Dagapur infront of SIMS Hospital, PS Pradhannagar, Dist-Darjeeling to the effect that on 16.05.25 during my evening mobile petrolling, I received source information that the hotel owner of Vishal Hotel is selling illicit liquor illegally at his hotel situated at Dagapur infront of SIMS Hospital, PS Pradhannagar, Dist-Darjeeling and he stored huge quantity of illicit liquor at his residence hotel without any valid documents. Accordingly, I diarized the fact in General Diary vide Pradhan Nagar PS GDE No. 852 dated 16.05.25 and informed the matter you. As per your kind order and direction, I accompany with SI Goutam Mallik, SI Rajiv Subba, ASI Prabal Sarkar, all of Pradhan Nagar PS left for Dagapur to work out the information with investigation kit by Govt vehicle. I briefed all the Police personnel sharing the information in hand and briefed them properly. At around 19:45 hrs we arrived at the said Hotel, and I along with other officers and force proceeded towards the hotel, noticing the Police personeel approaching close the hotel owner flew away from the spot. Further in the presence of independent witness we conducted searched the Hotel in presence independent witness and recovered Twelve (12) bottles of of "TUBORG" Premium Beer each bottle containing 650ml. and 09 (nine) bottles of 60 UP "HIMALAYAN GOLD" India made liquor each bottle containing 600ml. In local enquiry it found that the Hotel is owned by one Bijan Mahato S/O Lt. Ram Sunder Mahato of Panchanade, Bridge Dagapur, PS Pradhannagar, Dist Darjeeling and he is running such type of illegal business of selling illicit liquor at his hotel without any valid documents for his wrongful gain. As the said Bijan Mahato S/O Lt. Ram Sunder Mahato of Panchanade, Bridge Dagapur, PS Pradhannagar, Dist Darjeeling violated the norms of Bengal Excise Act. I accordingly seized the above noted illicit liquor under proper seizure list in presence of witnesses and brought to the PS for further investigation. The whole process of search and seizure were made under the coverage of video graph in between 20:05 hrs to 20:35 hrs at the spot.

I, therefore pray before your good self that a specific case may kindly be initiated against accused namely Bijan Mahato S/O Lt. Ram Sunder Mahato of Panchanade Bridge, Dagapur, PS Pradhannagar, Dist. Darjeeling, under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
