I, ASI Manoj Majumdar of NJP PS, Siliguri Police Commissionerate, do hereby lodge a written complaint, against one arrested accused person namely Binita Devi (52) w/o Pratap Thakur of South colony Bazar PS New Jalpaiguri Dist.-Jalpaiguri under arrest along with following seized articles;

1.04 (Four) bottles Mc dpwell's No 1 Luxury Blended Whisky ,each bottle containing 180 ml, marked as Ex-"A".

2.06 (Six) bottle 70 up Indian Made Liquire Himalayan Fatafati each bottle containing 300 ml marked as Ex-"B".

I am submitting a written complaint against the above noted accused personto the effect that today 16.03.25 morning I received source information that one person was selling Liquor illegally at South colony Bazar under NJP PS to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and I.C. NJP PS and as per his instruction myself along with C/1462 Sajan Tamang, VP-13 Jamirul Islam, VP 08 Laxman Roy L/C 1235 Anita Roy all of NJP PS, SPC left for South Colony to verify the veracity of information vide NJP PS GDE No. 947 Dated- 16.03.25. On arrival at the spot it was found that one person mentioned above was selling liquor illegally at her shop situated at South colony Bazar under NJP PS to her designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but somehow with the help of Lady constable, we apprehended the seller, on being asked he disclosed his name and address mentioned above and also confessed that she is selling Id Liquor illegally to her designated customers without any license. Thereafter in presence of witnesses I recovered 1) 04 (Four) bottles Mcdowell's No 1 Luxury Blended Whisky ,each bottle containing 180 ml, marked as Ex-"A". 2) 06 (Six) bottle 70 up Indian Made Liquor Himalayan Fatafati each bottle containing 300 ml marked as Ex-"B" from his possession and seized the same as per proper scizure List and labeled duly signed by her and also witnesses. On being asked she failed to produce any document or license for selling the liquor. As such I arrested the above noted accused person u/s 35 BNSS as It's a violation under Bengal Excise Act. The seizure & arrest was made on 15.03.25 in between 11-50 hrs to 12-25.

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Krishna Binita Devi (52) w/o Pratap Thakur of South colony Bazar PS New Jalpaiguri Dist.- Jalpaiguri and arrange for its investigation.
