In producing herewith following one (01) accused person namely Bivas Dutta (35) S/O Lt.Subhas Dutta of NJP Rail Hospital more, Bhuttabari, PS.NJP, Dist.Jalpaiguri under arrest and One iron made improvised fire arms having length approx nine inches fitted with trigger (Exhibit A") and One 8 mm live ammunition mark asK.F (Exhibit B'),

I, SI, Tanmay Kundu of NJP PS, SPC do hereby lodged this written complaint against one arrested accused person namely 1 Bivas Dutta(35) S/O Lt.Subhas Dutta of NJP Rail Hospital more, Bhuttabari, PS.NJP, Dist.Jalpaiguri

In this regard, I beg to report that today i.e. on 16.05.25 at 19.45 hrs, I received a specific secret information that one person namely Bivas Dutta had been coming from fulbari towards tinbatti area for committing heinous crime under PS-NJP, Dist- Jalpaiguri. Accordingly, I diarized the information in General diary vide NJP PS GDE No 975 dated 16.05.25 and informed the fact to you. As per your kind order and direction myself along with ASI Manoj Majumdar C/1462 Sajan Tamang VP 13 Jamirul Islam all of NJP PS left for Kamrangaguri near Railway over bridge side under PS- NJP, with investigation kit to work out the information by Govt. vehicle having no WB 77 4092 to verify the veracity of the information. Under such urgent circumstances any search warrant or authorization for search could not be obtained for want of time. So we had to move fast without affording the miscreant the opportunity for the concealment of evidence or facility for his escape. At 20.05 hrs we arrived at Kamrangaguri near Railway over bridge under NJP PS and as indicated by the source we noticed that one person was coming from fulbari side towards tinbatti. After seeing him we try to stop them but on seeing police personnel approaching towards him, he tried to flee away from the spot but on hot chase we managed to stop. them. On interrogation, he disclosed his identity as noted above. As per source information, he has possessed 01 improvised small Fire arm, hence, immediately we searched him and recovered One iron made improvised fire arms having length approx nine inches fitted with trigger and One 8 mm live ammunition mark as K.F which was kept concealed in the waist under the shirt of Bivas Dutta. The accused person namely Bivas Dutta possessed improvised Fire arm and total one live ammunition illegally. On demand he failed to produce any document in support of the said improvised Fire arm and one live ammunitions which was found from his exclusive possession. Thus, his involvement in carrying and possessing illegal Fire arm and ammunition was established, Then I seized the said iron made improvised fire arms

having length approx nine inches fitted with trigger and marked as "Exhibit A" and One 8 mm live ammunition mark as K.F and marked as "Exhibit-B under proper seizure list duly signed by the witness namely 1)Md. Ashirul (24) s/o Md. Basir of Tinbatti Colony PS New Jalpaiguri Dist Jalpaiguri 2)Md Arman (19) s/o Lt Md. Lalit of Tinbatti Colony PS New Jalpaiguri Dist Jalpaiguri and acknowledge by the accused person. The search, seizure and label were made in between 20:35 to 20:55 hrs and subsequently I arrested them by preparing memo of arrest and informing him the ground of arrest

Under the above noted facts and seizure of incriminating articles, there is strong reason to believe that the said accused person namely Bivas Dutta(35) S/O Lt.Subhas Dutta of NJP Rail Hospital more, Bhuttabari, PS.NJP, Dist.Jalpaiguri is desperate and dangerous in nature, and they were carrying the said Fire arm ammunitions with an ill motive to commit heinous crime in the locality. As they willfully violated the regulation of Arms Act, 1, therefore, I pray before your good self that a specific case may kindly be initiated against the accused person namely Bivas Dutta(35) S/O Lt.Subhas Dutta of NJP Rail Hospital more, Bhuttabari, PS.NJP, Dist.Jalpaiguri under proper section of law and its investigation may kindly be arranged.
