Sir,

In producing herewith three (03) arrested accused persons namely (i) Jiban Roy (21) s/o Habul Roy of Goghomali, near Sabitri Bhawan, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri [not verified] (ii) Shanta Das @ Bucchu (24) s/o- Jhantu Das of Goghomali Manisha Gulley, PO-Goghomali, PS- Bhaktinagar, dist- Jalpaiguri [not verified] and (iii) Rana Das @ Becha (26) s/o Narayan Das @ Pamucha of Madhya Hatiadanga, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri [not verified] arrested u/s- 35 BNSS along with following seized articles viz:

- (1) One iron made Hasua measuring 13 inch (approx.) including iron butt found from the possession of Jiban Roy which was kept in his right hand.
- (2) One iron made screwdriver measuring 8.5 inch (approx.) found from the possession of Rana Das @ Becha which was kept concealed on his back side.
- (3) One iron made rod measuring 5.5 foot (approx.) found from the possession of Shanta Das @ Bucchu which was kept in his back.

I, ASI Tapan Roy, S/O- Phanindra Roy of Ashighar OP under Bhaktinagar Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against the above-noted accused persons namely (i) Jiban Roy (ii) Shanta Das @ Bucchu and (iii) Rana Das @ Becha and others to the effect that today on 16/05/2025 at 01:30 hrs while performing night patrolling duty received source information that 12/14 youths have assembled at a vacant land near Jeremel's Academy School under Bhaktinagar PS with a view to commit dacoity in a house at Tellipara area. Accordingly, the fact was diarized in GD vide Ashighar OP GDE No- 480 dated 16/05/2025. Subsequently, after sharing the information with my superior and as per his direction, I along with ASI- Dinesh Ch. Roy, C/970 Bikash Roy, C/1547 Prabir Das, C-1686 Krishna Kanta Tiwari and CV/- 603 Arun Roy of Ashighar Out Post left for the Jeremel's Academy School to verify the veracity of source information. At about 01:55 hrs after reaching near Jeremel's School under PS- Bhaktinagar, I met my source and being pointed by the source we started walking towards Jeremel's Academy School. At around 02:10 hours, we reached near Jeremel's Academy School and began to cordon off the suspected individuals identified by our source. We had a strong reason to believe that they were preparing to commit a cognizable offence and were about to leave the area. However, upon noticing the police approaching, they attempted to flee. After a hot chase, we successfully apprehended three accused individuals along with the seized articles mentioned above. Unfortunately, a number of others managed to escape from the spot taking advantage of darkness.

During interrogation, the apprehended individuals admitted that they had gathered there with the intent to commit dacoity at a house in the Tellipara area under the Bhaktinagar police station.

I thereafter, seized the above-noted weapons under the proper seizure list and videography duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 02:25 hrs to 02:50 hrs. Following that, I arrested the above-noted accused persons u/s 35 BNSS under a proper memo of arrests duly signed by the accused persons and also supplied a copy of the memo of arrest to them.

Subsequently, I brought the arrested accused persons along with seized articles to Bhaktinagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house in Tellipara area.

Hence, under the above noted facts and circumstances a specific case may kindly be started under proper section of Law against the above noted arrested accused persons viz. (i) Jiban Roy (21) s/o Habul Roy of Goghomali, near Sabitri Bhawan, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri [not verified] (ii) Shanta Das @ Bucchu (24) s/o- Jhantu Das of Goghomali Manisha Gulley, PO-Goghomali, PS- Bhaktinagar, dist- Jalpaiguri [not verified] and (iii) Rana Das @ Becha (26) s/o Narayan Das @ Pamucha of Madhya Hatiadanga, PO- Goghomali, PS- Bhaktinagar, dist- Jalpaiguri [not verified] and others and arrange for its investigation.
