He even made me speak with his exams, during campus recruitment, he would be speak with his sister namely Puja Dey (Mob. No. 8617440277) on several occasions to reinforce his intentions. Based on his promises,

In May 2018, he took me to Pelling (Paksam Homestay - Owner: Ruby Limbu, Contact No: 097359 63819) and then to Darjeeling. Later in July 2018, he took me to Ranchi, Bhubaneswar, and Puri but the exact the location cannot be recalled at this point of time.

1. During these trips, under the promise of marriage, he forcibly established a physical relationship with me multiple

2. Claiming it was part of his academic project and journalism course requirements, he frequently traveled to various

Eventually, he confided in me that he was going through a major crisis. Despite being a bright student, his father had stopped supporting him financially, leaving him unable to complete his final year and project. He told me that suicide was the only option left unless I helped him financially. Wanting to support him and help him succeed, I transferred a

total of Rs. 2,22,000 to his bank account. He promised to return the amount within a year, claiming that he would secure a job and take an education loan to repay me. However, even after giving him this money, he continued to emotionally blackmail me with suicide threats to extort

When I started doubting his intentions, I asked him to provide receipts or proof of university fee payments, but he refused. I later explained my own financial difficulties, but instead of offering empathy, he became verbally abusive, used filthy language, and even physically assaulted me during a meeting.

He used to call me late at night in a drunken state and mentally harass me in unimaginable ways. I could no longer endure the constant abuse, lies, and torture. Eventually, I was forced to end all contact with him.

Sir, I have suffered both physically and mentally. Even after six years, he has not returned my money. Despite repeatedly asking for repayment and informing him about my current financial distress, he continues to abuse me with filthy language and has even issued death threats.

Today, I am filled with regret for trusting the wrong person and am mentally exhausted from the trauma I endured. I now seek justice and assurance of safety from your esteemed office.

I earnestly request you to take appropriate action against him and her sister with whom in collusion with has sexually abused me and also extorted money in several occasions. I shall remain ever grateful for your kind support.
