In producing herewith one arrested accused person namely Rohit Roy (22) s/o- Lt. Binoy Roy of Jaleshwari Bazaar, PO- Sahudangihat, PS- Bhaktinagar, Dist- Jalpaiguri along with the following articles under proper seizure list: -

[1] 12 (Twelve) sealed bottles of "HIMALAYAN GOLD 60 UP PET India Made Liquor each bottle containing 600 ml, i.e. 600*12=7200 ml, having M.R.P. of Rs. 160/- i.e. 160*12=1920/-, blended and bottled by Himalayan Endeavour Pvt. Ltd and is marked as "Exhibit-A" out of which 01 (One) bottle taken as a sample and marked as "Exhibit -A-1".

I, ASI Dinesh Ch. Roy s/o Lt. Madhu Roy of Ashighar OP under Bhaktinagar Police Station Siliguri Police Commissionerate do hereby lodge this written complaint against the above-noted arrested accused person namely Rohit Roy to the effect that today on 16/05/2025 at 16:15 hrs, I received a piece of source information that a person has stored the illicit liquor and is selling the same in his tin shed shop at Jaleswari Bazaar under PS - Bhaktinagar, Dist.- Jalpaiguri without any valid license. Accordingly, the fact is diarized in the General Diary vide Ashighar OP GDE No.454 Dated 16/05/2025, and shared the information with O/C Ashighar OP. As per his kind direction, I along with available force left for Jaleshwari Bazaar under PS - Bhaktinagar, Dist.- Jalpaiguri to verify the veracity of source information in hand. We reached there at about 18:05 hrs and as identified by the source we held a raid in a tin shed shop of Rohit Roy and managed to apprehend him. On being asked he disclosed his identity as noted above and stated that he has stored the illicit liquor and is selling the same at his tin shed shop without any valid license for his wrongful gain. On further search, the above-noted seized articles were recovered from his tin shed shop. On-demand he failed to produce any valid license/papers for selling and storing such articles. On further interrogation, he stated that he had been involved in selling and storing illicit liquor without any valid license for the last few months for his illegal gain. Then, I seized and labeled the above-mentioned liquor under the proper seizure list and arrested the person mentioned above named Rohit Roy after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 18:50 hrs. to 19:12 hrs under proper videography.

Under the above-noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against the arrested accused person Rohit Roy (22) s/o- Lt. Binoy Roy of Jaleshwari Bazaar, PO- Sahudangihat, PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
