With due respect, I Pabita Dab @ Choudhary (37/yr)  
W/o- Sambhu Choudhary of Simulquei Kalkut near Nirmala

like to inform you that - I was married with Sambhu  
Choudhary 9 year ago as per Hindu customs. After few  
months of marriage he assaulted and subjected both  
mentally and physical by my husband. I have three  
(03) Son's and he also do ~~torment~~ torture to them and  
assaults.

On. 07.05.2025 at about 20:00 hr when I return  
back from work (Shop Home) my husband started assaulting  
and beaten me. When I tried to protest he do beaten  
with punch and kick me and also threatened with  
dire consequence. As a result, I become unconscious  
and with the help of local people I was admitted in  
Siliguri District Hospital. I was delay to submit written  
complaint because local people said me to give him one  
more chance, but - till now he is not improving himself.

Therefore I will be very glad if you take necessary  
steps against him and grant my requisition.
