SUB: WRITTEN COMPLAINT

RESPECTED SIR,

I, Nishu Sahani, daughter of Ganesh Sahani, student by occupation, permanent resident of Methibari, Machuwa Busty, P.O- Salbari (Now), Sukna (old), P.S- Pradhan Nagar, District Darjeeling in the State of West Bengal Pin – 734002 (Now), 734009 (old) would like to inform you as follows: -

1. That I had been facing a harassment since one and half year approx. from my cousin brother namely ANISH SAHANI @ BHOLA, son of Kapil Dev Sahani, resident of Methibari, Machuwa Busty, P.O- Salbari (Now), Sukna (old), P.S- Pradhan Nagar, District Darjeeling in the State of West Bengal Pin – 734002 (Now), 734009 (old).
2. That my said cousin is the son of my father's brother son and we belong to the same family.
3. That the matter got started since one and half year ago when I had attended one of my local villager's marriage functions and in the said marriage ANISH SAHANI @ BHOLA was also present as he also resides in the same village near my house.
4. That in the said marriage party the said ANISH SAHANI @ BHOLA asked me and my friends to take selfie and I allowed him to do so as we were taking selfie in group and moreover, he was my cousin brother and he had also clicked my single photos and had taken my phone number in order to send my photos which he had clicked with his phone.
5. That on the next day of the said marriage function, ANISH SAHANI @ BHOLA had sent me my photos in my whatsapp and started to flirt with me by asking me not to call or address him as a brother (bhai) rather to call him by his name.
6. That after the above conversation he began to text me everyday to which I had protested and had asked him to stop sending such flirting messages to which he would turn a deaf ear.

7. That on several incident whenever I use to block him in whatsapp or in call, he would block my way whenever I would be on my way to tuition and would forcefully snatch my phone and would unblock him from my phone and in some instances he had even come to my school and would take away my mobile which he would return after few hours or on the next day.
8. That the said ANISH SAHANI @ BHOLA began to threaten me to face with dire consequences if I happen to block or ignore him or if I complain about him to anybody and would ask me to be in relation with him and to run away with him.
9. That the threatening from him began to increase day by day and had even threatened me to leak my photo after editing in vulgar context in a way that is inappropriate or offensive throughout the social media platform.
10. That during the whole incident I kept mum and I did not inform anything to my parents as I was in fear that they would scold me and moreover he is my cousin brother and the thing would turn towards different path if I had opened up to my parents.
11. That 06 (six) month back my elder brother namely Laxman Sahani came to know about it and intervened in the matter and tried to solve this matter internally as the problem was with the extended family members.
12. That several meetings were conducted within our family members and well-wishers by my elder brother and the matter was settled for the time being, after which the said ANISH SAHANI @ BHOLA was sent to Bihar at his home.
13. That during his stay in Bihar the said ANISH SAHANI @ BHOLA's mother would abuse me on daily basis and would threaten me to kill by putting a fire in my body.
14. That after staying in Bihar for about 05 (five) months the said ANISH SAHANI @ BHOLA has returned back and had messaged me in WhatsApp from a new number asking about my date of marriage which he claims that he have heard from the local villagers and has been threatening me that he would not allow me to get marry with any other person and when I ignored him to reply his messages he video called me through his whatsapp account for about 62 times the screen shot of which has been attached herewith.

15. That I narrated the whole incident to my elder brother Laxman Sahani and after which the said ANISH SAHANI @ BHOLA has also started to threaten my brother too and has been continuously threatening me to post my photo after editing in vulgar context in a way that is inappropriate or offensive throughout the social media platform.

Therefore, in the light of above stated facts I hereby request you to register my complaint as I been a prolonged victim of harassment by ANISH SAHANI @ BHOLA and I am living in daily fear that he might do something wrong to me and my family members to get his malafied intention which is also a disgrace towards our human society.
