Sir,

In producing herewith one arrested accused namely Rajib Singh(38) S/o Lt. Binod Singh of Battola near Ganga Mandir PS Pradhan nagar Dist. Darjeeling along with following seized articles as per seizure list viz :- (i) One blue colour TATA truck bearing registration number WB-76-2026 loaded with illegal river bed materials and (ii) 04 numbers of shovels.

I, ASI Jagannath Roy of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the driver and owner of the above mentioned seized vehicle having registration number WB-76-2026 to the effect that today on 19.05.25 at around 06.30 hrs., I received a specific source information that illegal mining of river beds materials is going on along NH 10 under Pradhan Nagar P.S. Dist. Darjeeling and the owner and drivers loaded river beds materials illegally in their trucks to sell the same to their design customers for their illegal gain. Accordingly, I diarized the matter in PS General Diary vide Pradhan Nagar PS GDE No. 984 dated 19.05.2025 and informed the matter to you and as per your kind order and direction myself accompanied with force started checking near Regulated Market gate No. 2 to verify the veracity of the information.

At around 06.35hrs. we detained the vehicle bearing registration number WB-76-2026 loaded with river bed materials being pointed by the source near Regulated market gate no-2 under Pradhan nagar PS. On asking the driver disclosed his identity noted above and failed to produce any valid documents in respect of the said river bed materials, carrying with his vehicle. On further interrogation he stated that he mines river bed materials from Mahananda rivar by illegal means and loaded the same in the vehicle to sale the same to their design customers for their illegal gain. Accordingly, I seized the above mentioned vehicle (Tractor) having registration number WB-76-2026 loaded with illegal river bed materials and 04 nos. of Shovels under proper seizure list from the spot under section 106 BNSS. The entire process of search and seizure was made under the coverage of videography in between 06.39 hrs to 06.53 hrs as per norms of BNSS and arrested the accused driver namely Rajib Singh(38) S/o Lt. Binod Singh of Battola near Ganga Mandir PS Pradhan nagar Dist. Darjeeling following legal procedures and stating ground of arrest and brought to Pradhan Nagar PS/SPC for further necessary action.

Under the above circumstances, I, pray before you that a specific case under proper section of law may kindly be started against the arrested accused Rajib Singh(38) S/o Lt. Binod Singh of Battola near Ganga Mandir PS Pradhan nagar Dist. Darjeeling and arrange for its investigation.
