Kundu of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this writte and the matter to O/C Bagdogra PS and a ama, C/1509 Sourav Roy Sarkar, CV/37 Barman & CV/389 Janak Singh left for Sanyasisthan TE under Bagdogra PS, SPC to work or the secret source information. This refers to Bagdogra PS GDE No. 800 dated 16.05.2025. At aroun 19:20 hrs we reached at Sanyasisthan TE and being indication & identification by source we held raid the house cum shop of the suspect and detained the suspect there with the help of accompanying Police personnel and interrogated him. On interrogation, he revealed his identity as Pradeep Munda, aged 3 yrs, s/o- Late Nirmal Munda, resident of Sanyasisthan TE, Quarter Line, PS- Bagdogra, Dist- Darjeelin (not verified) and he introduced himself as the owner of that house cum shop. We disclosed our identit to him and the input we had. We contacted with the local people to be present as witness during th process of search, seizure, if any. But none agreed to be present there as witness. Then, we searched th house cum shop in presence of the Police personnel. On search, the above noted liquor was recovere from the said house cum shop. On demand, he failed to produce any valid document/license for possessing, stocking & selling that liquor. He confessed that he had been possessing, stocking & sellin liquor illegally from his house cum shop since long time for his wrongful gain. His involvement is we transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list and a last, arrested the involved accused Pradeep Munda (as noted above) after observing all legal formalitie and communicating him the ground of arrest as he has committed a cognizable offence in presence of Police for possessing, stocking & selling that liquor illegally from his house cum shop and issued mem of arrest in this regard. The process of search, seizure & arrest was made in between 19:30 hrs an 19:50 hrs on 16.05.2025. The entire process of search, seizure & arrest is done through audio-vide electronic means using mobile phone and then the same audio-video record is converted to a pen driv using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person namely Pradeep Munda, aged 35 yrs, s/o- Late Nirmal Munda resident of Sanyasisthan TE, Quarter Line, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for its investigation.
