Sir,

In producing herewith the accused person namely Pradeep Munda, aged 35 yrs, s/o- Late Nirmal Munda, resident of Sanyasisthan TE, Quarter Line, PS- Bagdogra, Dist- Darjeeling (not verified) and custody along with following seized articles under proper seizure list:

1. Five (5) ltrs 'Caullu' in one plastic jar and marked as Exhibit-A.
2. Eleven (11) bottles of Himalayan Gold 60° UP India Made Liquor, each contains 600 ml @ Rs. 150/-, out of which 01 bottle is taken out as sample and marked as Exhibit-B.  
(Total 11.5 ltrs, total value Rs. 1760/-)

SI Debabrata Kundu of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written complaint against the arrested accused person namely Pradeep Munda, aged 35 yrs, s/o- Late Nirmal Munda, resident of Sanyasisthan TE, Quarter Line, PS- Bagdogra, Dist- Darjeeling (not verified) to the effect that on 16.05.2025 at 19:05 hrs received reliable source information that a huge quantity of liquor is stored at the house cum shop of one suspect Pradeep Munda at Sanyasisthan TE under PS- Bagdogra and the same has been selling illegally. Accordingly, I informed the matter to O/C Bagdogra PS and in his direction I along with SI Binup Mahato, ASI Amit Lama, C/1509 Sourav Roy Sarkar, CV/37 Jogesh Barman & CV/389 Janak Singh left for Sanyasisthan TE under Bagdogra PS, SPC to work on the secret source information. This refers to Bagdogra PS GDE No. 800 dated 16.05.2025. At around 19:20 hrs we reached at Sanyasisthan TE and being indication & identification by source we held raid at the house cum shop of the suspect and detained the suspect there with the help of accompanying Police personnel and interrogated him. On interrogation, he revealed his identity as Pradeep Munda, aged 35 yrs, s/o- Late Nirmal Munda, resident of Sanyasisthan TE, Quarter Line, PS- Bagdogra, Dist- Darjeeling (not verified) and he introduced himself as the owner of that house cum shop. We disclosed our identity to him and the input we had. We contacted with the local people to be present as witness during the process of search, seizure, if any. But none agreed to be present there as witness. Then, we searched the house cum shop in presence of the Police personnel. On search, the above noted liquor was recovered from the said house cum shop. On demand, he failed to produce any valid document/license for possessing, stocking & selling that liquor. He confessed that he had been possessing, stocking & selling liquor illegally from his house cum shop since long time for his wrongful gain. His involvement is well transpired in this case. Accordingly, I seized that liquor (as noted above) under proper seizure list and at last, arrested the involved accused Pradeep Munda (as noted above) after observing all legal formalities and communicating him the ground of arrest as he has committed a cognizable offence in presence of Police for possessing, stocking & selling that liquor illegally from his house cum shop and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 19:30 hrs and 19:50 hrs on 16.05.2025. The entire process of search, seizure & arrest is done through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person namely Pradeep Munda, aged 35 yrs, s/o- Late Nirmal Munda, resident of Sanyasisthan TE, Quarter Line, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for its investigation.
