would like to register a complaint on Rounak Day Sarkar
son of Mr. Geotam Day Sarkar about a serious assault he
committed on my son Sri Anuran Saha on 16th May 2025.
Rounak Day Sarkar gave a call on my sons phone at around
12:35 PM and started abusing my son using slang language.
Further he threatened my son by coming near my house
and on phone call he asked him to come out and meet
for a certain talk. As soon as my son goes out of
my house he started hitting my sons face by using
some metal weapon worn on his fist. He continuously
hit on his face and chest till he fell on ground. and
his teeth has broken.
Then he went away on his scooter as I and my
neighbours arrived on spot. As soon I saw my son
bloodshed I rushed him to Siliguri Hospital, where
doctor conducted the necessary treatment and admitted
him.
