In producing here with the following seized article: (1). 100 (one hundred) bottles of country spirit styled as "Himalayan Tuk Tuk" 80 UP each containing 600 ml in each bottle, Total 60,000 ml.

The brief fact of the case is that on 16/05/2025 at 14:20 hrs I SI Mrityunjay Roy along with forces while performing special raid duty (vide Mtg PS GDE NO-1053 dated 16/05/2025 and MCC No2278/25 date 16.05,25, received an source information that one person was stored and selling huge quantity of illicit country spirit at his house at kalabasty, Patiramjote, PS Matigara, Dist. Darjeeling. Accordingly I informed the matter to I.C Matigara Police Station and duty officer and as per direction of I/C Matigara PS, I along with my force Constable, 154, Mihir Roy and constable 193, Malekul Tslam left towards Patiramjote (Kalabusty) under Matigara PS to work out the information.

Having no other alternative, I seized 100 (one hundred) bottles of country spirit styled as "Himalayan Tuk Tuk" 80 UP each containing 600 ml in each bottle total 60,000 ml, Batch No 554TT006(3) Date April/2025, MRP Rs 60/- only each bottles under proper seizure list in presence of witnesses in between 14:58 hrs to 15:10 hrs and labeled the same and taken in my custody.

On reaching at PS, on 16/05/2025 at 15:50 hrs I prepared this complaint and handed over the Alamats, along with all related documents before you with a prayer for starting a specific case against the owner of seized articles onted above under proper section of law.
