Sub: First Information Report.

Respected Sir,

I, SMT. GAYATRI KUMARI, Wife of Shri Rajat Prakash, Daughter of Shri Vijay Prasad, permanent resident of Khaprail, near TCP Check Post, P.O.- New Chumta, P.S.-MATIGARA Sukna, District- Darjeeling, PIN- 734009, in the state of West Bengal, would like to lodge this complaint and state as follows:

That I married Shri Rajat Prakash, Son of Late Atul Kumar, currently residing at Tower 26, Flat No. 403, 4th Floor, Nirala Estate, Patwari, Greater Noida, PIN- 201318, Uttar Pradesh and are permanent residents of MIG-128, Navjeevan Vihar, P.O.-Vindhyanagar, Singrauli, PIN- 486885, Madhya Pradesh, on 28th November 2023, according to Hindu rites and customs in the presence of family and friends. After the marriage we, stayed together along with my mother-in-law Mrs. Mridula Gupta, W/o Late Atul Kumar, at MIG-128, Navjeevan Vihar, P.O.- Vindhyanagar, Singrauli, PIN-486885, Madhya Pradesh.

Other than gifts, jewellery, gold, silver, clothings, electrical appliances and utensils, my husband and in- laws had taken Rs. 2,00,000/- (Rupees Two lacs only) in cash and Rs. 2,94,000/- (Rupees Two lacs Ninety four thousand only) through NEFT, as dowry in our wedding. Our families had initially agreed upon splitting the expenses of the marriage, however, 30 (Thirty) days before the wedding, my mother-in-law had called my father and informed that they would not contribute to the expenses. In order to save ourselves from humiliation of any kind, before our family and the society at large, my father had with utmost helplessness and beyond affordability, agreed to bear the entire

wedding expenses and arrange for dowry, by spending all the savings he had, including my PF(s) investments.

My sister-in-law, Mrs. Poorvi Gupta, resident of Lodha Splendora Celio, C Wing, Flat No. 1101, Bhayandarpara, Ghodbhunder Road, Thane West, Thane, PIN- 400615, Maharashtra, had insisted me to hand over all my possessions, cash and gifts to her. Further, in no time my mother-in-law took all my jewellery, gifts in marriage and cash into her custody. Neither my husband nor my mother-in-law gave me a single penny for my day to day expenses. My sister-in-law made caste based remarks on me calling me "teli". My mother-in-law and husband supported her in the same and used foul languages towards me and my family.

My husband and I had been to Mumbai to meet my sister-in- law and her husband Shri Vikas Gupta. My husband was looking out for a residence in Pune, which was his the then job place. On 23.12.2023, I had accompanied my husband, sister-in-law and brother-in-law to Pune and while looking out for a place of residence, my husband and in- laws were selecting options favourable only to my husband. When I asked my husband as to why were they not availing of options which would be convenient to both of us, my husband and in- laws shouted upon me stating that my job was not a thing for them and compelled me to leave the thought of getting back to work again. However, I neglected it, thinking that they had said the same in a mode of anger. However, later that evening my sister-in-law denied me food and left me alone.

My mother-in-law who had before marriage agreed to the fact that I would continue with my job, had immediately after the wedding, refused the very idea of me taking up a job, thereby causing immense mental torture upon me. My husband and mother-in-law used to inflict physical and mental torture upon me and would ask me to extort money from my parents, since the dowry was according to them not up to the mark, they would call me names and use foul words against my parents but with the fear of losing the marital tie I never made reports to the Police Station.

My mother-in-law would time and again threaten me of dire consequences if I did not leave their house. Despite such cruelty and harassment I kept on adjusting with the situation with the hope that situations would get better with the passage of time.

Finally on 26.12.2024, a major quarrel took place between my husband and I, wherein my husband slapped me multiple times and pushed me on the floor for not meeting their demands. My mother-in-law supported him and asked me to leave the house or they would kill me. Thereafter, I was compelled to leave my matrimonial house by my husband and mother-in-law. When the neighbours stared questioning as to what happened, my husband told it was a misunderstanding between my husband and I. to save his reputation, my husband asked me to go back to my parental house until the situation pacified. He immediately got the travel ticket done and assured me that he would come to get me back. I was put out of my matrimonial house with two sets of clothes only, since my husband assured that he would get me back in a couple of days, meanwhile all my important documents, stridhan, and other belongings remained in the custody of my husband and mother-in-law. Thereafter I had to call my parents, inform them of the situation and get back home. I was shocked when my husband stopped taking calls from me and my family members. Days passed by but there was no talk or response from my husband and in-laws. Finding no other alternative my parents and I went to my matrimonial home, but it was under lock and key and it was through the neighbours that I got to know that they had shifted to some other place. I kept calling Mrs. Poorvi Gupta and her husband to seek the whereabouts of my husband and motherin-law but they did not entertain me.

I went to my sister-in-law's house and they were shocked to see me there and stated that my mother-in-law was ill and hospitalized. It is pertinent to mention that my husband who never took a call from me or my family members, suddenly contacted me and told me that they would settle the matter once my mother-in-law is well and when I cried in front of the in-laws stating where would my mother and I go in the middle of the night, then to put me out of the house of my sister-in-law, my husband booked a hotel 37 kms away from the residence of the former.

Even after episodes of torture, I had the faith, that my husband and in- laws would reconcile with me. I kept on calling and messaging my husband about the whereabouts of my mother-in-law but they would defer dates after dates on various pretexts. Meanwhile I got to know, that my husband had an extra marital affair, which shattered me completely. My husband deserted me in the first instance, but to secure himself and his family from any legal repercussions, he filed a suit for Restitution of Conjugal Rights, u/s 9 of the Hindu Marriage Act, 1955, before Ld. Family Court, at Ghaziabad, which was botched up with the intent to harass me even further. I called him up several times to take me back home but got no positive response. Be it pertinent to mention that it has come to my knowledge that my husband and mother-in-law never stayed in Ghaziabad, it was to institute a case in there, that they put forward a hypothetical address which in all probability will be supported by fabricated documents. On the date of hearing, that is 16.08.2024, I waited for my husband outside the Ld. Court, however, he did not turn up.

That thereafter, it came to my knowledge that my husband and mother-in-law are residing at Tower 26, Flat No. 403, 4th Floor, Nirala Estate, Patwari, Greater Noida, PIN- 201318, Uttar Pradesh. On 16.09.2024, I went to their residence but the mother and son created ruckus and called the police and security guards, when things did not go as planned by them, they called an unknown person who pretended to be the landlord and asked me to vacate the house. My husband and mother-in-law created a scene and told me that we would have to shift to some hotel, since the landlord was disturbed by the chaos. As such we went to a hotel, where my mother-in-law physically assaulted me, slapped me and kicked me with the help of her son as a consequence of which I sustained bruises and injuries on my face and arm and there were blood clots all over my body and they warned me to settle the matter as per their terms and conditions, failing which I would have to face trouble.

On 20.09.2024, I informed my parents of the intention of my husband and in-laws. My parents arrived on 21.09.2024, even after lot of discussions and persuasions from my

parents and I, they remained unperturbed. My parents agreed to all that said and demanded so that things could be resolved at the that moment. My husband was trying to leave the hotel, when my father saw him and tried to stop him, but the mother and son faked tantrums accusing my parents and I of harassment and the matter escalated. My family and I tried to settle the matter a lot of times but to our utter dismay, they were never ready to co- operate.

I requested my husband to give time to our marriage and not desert me but he paid no heed. I also requested him to atleast hand over my original documents so that I could lead a normal life, but he denied the same stating that I deserved all the harassment and I should not think of getting back unless I fulfilled their demand of extracting another Rs. 8,00,000/- (Rupees Eight Lacs only) from my parents and made it clear that his only intention to file the restitution case was a precautionary and pretentious attempt to establish himself as innocent in the eyes of law.

In the month of February, 2025, my husband came down to Siliguri and followed me from my house to Check Post. I could sense someone following, when suddenly he obstructed my way and threatened that he would kill me if I did not get him the money he is demanding for and told me had I instituted any case against him or his family he would not hesitate to kill my family members too. He fled away the moment I started shouting on the road. I was numb and still had the last hope that if not my in-laws my husband would make an attempt to live a normal matrimonial life with me. But all the wait and pain yielded no results.

On 08.05.2025, Ld. Family Court at Ghaziabad, pronounced the judgment in the restitution of conjugal rights case, stating that the prayer of the Petitioner, that is my husband, wherein the Court should order me to go and lead a matrimonial life with him stands rejected because of the cruelty and torture he has inflicted upon me. Consequent upon which my husband and mother-in-law threatened me again in the Court premises, that they would malign my reputation and put me to death if I did not surrender to their

terms and conditions and if I did not fulfill their demands immediately they would make sure that my family never gets to see me again in their lifetime.

My husband and in-laws have treated me with immense cruelty and committed criminal breach of trust and cheated upon me with criminal intent, with the intention to plunder me of all my valuables, money and emotions, in the name of marriage. My sister-inlaw and brother-in-law are equally liable for concealing the whereabouts of my husband and mother-in-law and inflicting immense torture upon me.

My husband, mother-in-law, sister-in-law and brother-in-law have in consensus and with a common intention hatched a criminal conspiracy against me and subsequently have for their personal gains cheated, committed breach of trust and thereafter misappropriated all my stridhan properties, which were lying in their custody.

I request Your good office to kindly treat this as urgent and book these miscreants under the laws of the land and oblige.
