Sir,

With due respect I, SI Sailesh Subba of Bhorer Alo P.S, SPC would like to lodge this written complaint against the absconded accused person namely Chandan Mondal s/o Late Basudev Mondal of Mohamaya Colony, P.O Kamarvita, P.S Bhorer Alo, Dist. Jalpaiguri after producing the following seized articles under proper seizure list viz:

- i. Sixteen (16) sealed Bottles of "PET GALAXY BOSS 60 U.P INDIA MADE LIQUOR" each bottle containing 300 ml when packed and marked as "Exhibit-A" out of which one bottle is taken as sample and marked as "Exhibit-A1". [Total 16 X 300 ml =4.8 Litres]
- ii. Three (03) sealed Bottles of "ICONIQ WHITE" special International Grain Whisky each bottle containing 375ml and marked as "Exhibit -B" out of which one bottle is taken as sample and marked as "Exhibit-B1". [Total 3 X 375 ml = 1.125 Litres]
- iii. Two (02) sealed Bottles of "Mc Dowells No. 1 Luxury Blended Whisky" each bottle containing 375ml and marked as "Exhibit -C" out of which one bottle is taken as sample and marked as "Exhibit-C1". [Total 2 X 375 ml =0.75 Litres]

to the effect that today on 16.05.2025 at about 20.25 hours I along with force while performing my special van duty under Bhorer Alo Police Station vide Bhorer Alo PS GDE No. 623, Date: 16.05.2025 received a source information that one Chandan Mondal of Mohamaya Colony is selling illicit liquor in his shop cum house. The matter was informed to Officer-In-Charge, Bhorer Alo PS over phone and as per his kind order myself along with force of Bhorer Alo PS left for Mohamaya Colony to verify the information.

At about 20.55 hours I along with force reached at Mohmaya Colony and being shown and identified by the source I along with force held raid at the shop cum house of said Chandan Mondal but after seeing the Police team the said Chandan Mandal managed to flee away from the spot. Further in presence of available witnesses I, along with my accompanied team entered into his house and being searched his shop recovered huge amount of above noted seized liquor from his shop.

During local enquiry the owner of the shop cum house is identified as Chandan Mondal s/o Late Basudev Mondal of Mahamaya Colony, PO Kamarvita, PS Bhorer Alo, Dist. Jalpaiguri. On further enquiry it came to learnt that he has been involved in selling and possessing of illicit liquor in his shop cum house since long without any valid license for his illegal gain. The absconded accused person Chandan Mondal has violated the norms of Bengal Excise Act. Hence, I seized the above mentioned liquor under proper seizure list after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 16.05.2025 in between 21.02 hours to 21.15 hours.

Under the above noted circumstances I, pray before your good self that a specific case under proper section of law may kindly be initiated against absconded accused person namely Chandan Mondal s/o Late Basudev Mondal of Mohamaya Colony, PO Kamarvita, PS Bhorer Alo, Dist. Jalpaiguri and may arrange to cause its investigation under Bengal Excise Act.
