

In producing herewith following three accused persons namely (i) Arman Hussain (M/28 years), s/o- Basaruddin Ahmed, r/o- Sadaritola, PO- Sahabajpur, PS- Kaliachak, Dist- Malda (ii) Rafikul Islam (M/27 years), s/o- Jiyaul Hoque, r/o- Sadaritola, PO- Sahabajpur, PS- Kaliachak, Dist- Malda and (iii) Babai Debnath (M/31 years), s/o- Late Bablu Debnath, r/o- Bhujiapani near Khatal, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles:

- (i) One blue colour Swift four wheeler displaying No. WB66AT/9699 along with its ignition key.
- (ii) One iron made 'Plus' with red colour plastic cover handle, marked as Exhibit-A.
- (iii) One iron made 'Hexo blade' with wooden handle, marked as Exhibit-B.
- (iv) One Screw driver with green colour plastic handle, marked as Exhibit-C.
- (v) One iron made 'shabal' measuring approx length two feet, marked as Exhibit-D.
- (vi) One iron made 'da' measuring approx length 10 inches &width 02 inches, marked as Exhibit-E.
- (vii) One nylon rope measuring length approx ten feet, marked as Exhibit-F.
- (viii) One POCO M4 Pro Android mobile phone having IMEI No. 861737061991423/78, marked as Ex:G.
- (ix) One NOKIA Keypad mobile phone having IMEI No. 358681184123680/98, marked as Ex:H.
- (x) One OPPO F27 Pro+ Android mobile phone having IMEI No. 861654070184710/02, marked as Ex:I.

[Note: (i) Ex:A is recovered & seized from the possession of accused Arman Hussain.

- (ii) Ex:B is recovered & seized from the possession of accused Rafikul Islam.
- (iii) Ex:C is recovered & seized from the possession of accused Babai Debnath.
- (iv) Ex:D, E, F, G, H & I are recovered from the four wheeler (Swift) displaying No.

WB66AT/9699 and seized from their joint possession.]

I, SI Debabrata Kundu of Bagdogra PS, SPC, do hereby lodge this written complaint against the above noted arrested three accused persons and other 3/4 absconding accused persons to the effect that today on 18.05.2025 at 00:05 hrs I received reliable source information that some suspects have assembled at Bhujiapani Kali Math under Bagdogra PS with a vehicle (four wheeler) and they have been preparing to commit dacoity. Accordingly, I informed the matter to O/C Bagdogra PS and diarized the matter in GD vide Bagdogra PS GDE No. 855 dated 18.05.2025 and formed a raiding team consisting SI Binup Mahato, ASI Munna Ahmed, ASI Amit Lama, VP/01 Anselam Kujur, VP/02 Pradip Roy & CV/386 Kishor Howladar leaded by me. Then at 00:10 hrs as per direction of O/C Bagdogra PS, we left for Bhujiapani Kali Math under Bagdogra PS vide MCC No. 983/25 dated 18.05.2025 by Govt. vehicle No. WB68Q/6401 to work out the secret source information. This refers to Bagdogra PS GDE No. 856 dated 18.05.2025. At around 00:25 hrs we reached near Bhujiapani Kali Math and made an ambush there and waited for source indication. We parked our Govt. vehicle away from the place. After a while, source indicated us the group of suspects. There were a group of about 6/7 suspects. Then, being shown & indication by source we started to cordon them from all side. All on a sudden some of them noticed us and tried to flee away from the spot. But after hot chase at around 01:55 hrs we managed to apprehend three suspects there in red hand and searched their persons. They were armed with deadly weapons and equipments to commit dacoity, house breaking etc. Accordingly, we interrogated them. On interrogation, they could not give any satisfactory answer regarding their presence at that place at the odd hours of night. They gave different statement in different times. Finally, they revealed their identity as (i) Arman Hussain (M/28 years), s/o- Basaruddin Ahmed, r/o-Sadaritola, PO- Sahabajpur, PS- Kaliachak, Dist- Malda, (ii) Rafikul Islam (M/27 years), s/o- Jiyaul Hoque, r/o- Sadaritola, PO- Sahabajpur, PS- Kaliachak, Dist- Malda and (iii) Babai Debnath (M/31 years), s/o- Late Bablu Debnath, r/o- Bhujiapani near Khatal, PS- Bagdogra, Dist- Darjeeling (not

verified). Finally, they confessed that they had assembled there in order to commit dacoity at Bhujiapani area. Their other associates somehow managed to flee away taking advantage of darkness. We searched for independent witnesses but no independent witness could be found available there at the odd hours of night. Accordingly, I arranged to search their persons. On search, one four wheeler (Swift) displaying No. WB66AT/9699, one iron made 'Plus', one iron made 'Hexo blade', one Screw driver, one iron made 'shabal', one iron made 'da', nylon rope & three mobile phones were recovered from their joint possession. Accordingly, I seized the recovered articles under proper seizure list & labelled in presence of police witnesses. Finally, I arrested them after communicating them the ground of arrest in writing and after observing the legal formalities as they have committed a cognizable offence in presence of Police Officer to prevent them from committing any further offence as well as for proper investigation of the case and issued memo of arrest in this regard. The process of search, seizure, label & arrest was made in between 01:55 hrs & 02:15 hrs on 18.05.2025. The entire process of search, seizure & arrest is done through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.

Under the above facts & circumstances, I request you to initiate a specific case under proper sections of law against the above mentioned involved arrested accused persons namely (i) Arman Hussain (M/28 years), s/o- Basaruddin Ahmed, r/o- Sadaritola, PO- Sahabajpur, PS- Kaliachak, Dist-Malda, (ii) Rafikul Islam (M/27 years), s/o- Jiyaul Hoque, r/o- Sadaritola, PO- Sahabajpur, PS- Kaliachak, Dist- Malda and (iii) Babai Debnath (M/31 years), s/o- Late Bablu Debnath, r/o-Bhujiapani near Khatal, PS- Bagdogra, Dist- Darjeeling (not verified) & 3/4 other absconding accused persons and arrange for its investigation.
