1 Sri Sarvesh Kumar Agarwal, Son of Sri Nisith Kumar Agarwal, resident of "Shyama Kunj", Punjabi Para, P.O- Hyderpara, P.S- Bhaktinagar, Dist-Jalpaiguri, is one of the director of the company namely Sarvambh Property Developers Pvt. Ltd. having its office at Neelkamal Plaza, Opp- Meghdoot Cinema Hall, Hill Cart Road, P.O & P.S- Siliguri, Dist- Darjeeling, PIN-734001, beg to inform you that our said company is the registered and recorded owner of the land measuring about 0.355 Acre, situated at Mouza-Siliguri Madhya, recorded in L.R Khatian No- 2734, comprised in L.R Plot No- 3258,3259 and 3262, within the Police Station Siliguri, Ward No- 8 (S.M.C), Dist- Darjeeling. That the said land was purchased by me on 09/04/2024 vide registered deed of sale being No- 836 for the year 2024. That prior to purchase of the said land there was an old and dilapidated concrete structure, which is popularly known as "Jai Hind Building" on the said land. Subsequently in pursuance of the order passed by the Hon'ble High Court at Calcutta Circuit Bench at Jalpaiguri, in writ petition No- WPA 1529 of 2023, the Siliguri Municipal Corporation after hearing of an application filed by the then owner, the Siliguri Municipal Corporation passed an order to vacate the building namely "Jai Hind Building", and the Executive Engineers and the engineering team of Siliguri Municipal Corporation was directed to take necessary steps to demolish/dismantle of the said building.
