He used to ask me for monetary help with a promise to return and in good faith I use to give him cash and sometimes through G-Pay. But he never returned the money so, I stopped talking to him. All of a sudden, in the end of March, he again asked for monetary help crying that his mother is admitted in hospital due to heart attack for which I denied as I am also a student and don't have huge sum of money to pay the hospital bill. Furthermore, he asked my gold chain and promised to return within one week for which I gave him my gold chain but even after two weeks he did not returned the gold chain and I asked him to return my gold chain but he refused to return my chain instead he started threatening and blackmailing me and said that "if you ever ask me again for your gold chain I will post your private photo over the internet/social-medias and if you don't want me to post your private photos and video then give me more money". I was so frightened I said the incident to my sister and she called through mobile phone he sent filthy messages to my sister from my instagram account which he used to use as he have taken my password forcefully and used to chat to other personating as me.

So, finding no other way I had come to Matigara Police Station on 9th May 2025 I was asked to wait till 16th May 2025 as the abovenamed person asked time to return my gold chain but on 16th May he did not returned my gold chain and I was asked to wait till 18th May 2025 again the abovednamed prson paid no heed and did not returned my gold chain. So,

today being aggrieved, threatened and mentally harassed by the abovenamed person so I came before the said Police Station for protection of my name, reputation, character and future.

Therefore, I would be grateful if you would arrest the said abovnamed person and stop him from further spoiling my name, reputation, character and which will definitely affect my future and this arrest may stop more girls to become his prey and help society in large.
