In producing herewith the three accused persons (i) Sonam Sha@Sah(25yrs)/F, W/Specified Charge Sk. Of Babaloknath Colony, PS- Matigara, Dist- Darjeeling, (ii) Ohidur Sk(27 yrs)/M, S/O Badiruddin of Narayanpur, PS- Kaliachak, Malda, (iii) Abdul Rauf(30 yrs)/M S/O Badiruddin PS- Kaliachak, Malda) along with the following seized article under proper seizure list :-

- i. One packet (transparent) containing weight 1 kg 260 gram suspected to be brown sugar and marked as Exhibit "A".
- ii. One packet(transparent) containing weight 780 gram suspected to be brown sugar and Marked as Exhibit "B".
- iii. Two packets of white colour Powder in one plastic bag containing weight 9 kg 268 gram style as Sodium Carbonate SQ 30159 and marked as Exhibit "C".
- iv. One bottle of water like substance approx. 2 litre marked as Exhibit D
- v. One bottle containing 500ml of Acetyl Chloride and marked as Exhibit "E".
- vi. Total sum of Money Rs 12, 64,200. /- (Twelve lakh sixty four thousand and two hundred only) Denomination (Rs 500 x 2416=12,08000,-, Rs 200x221=44,200/- & RS 100x120=12,000/-)
- vii. One vivo phone IMEI No. 8686750079184498".

I, SI Prasan Tamang of Matigara PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against above noted three arrested accused persons to the effect that today i.e. on 20.05.2025 during my evening k 32 mobile van duty vide Matigara PS MCC No. 2312 dated : 20.05.2025 due some enquiry I was at the PS where at the nick of time at 15.05hrs dated 20.05.2025, I received a secret source information that three persons has store huge quantity of suspected to be Brown Sugar at particular house at Bablokknath Colony Simultala, under Matigara PS Dist Darjeeling to deliver the same to their designated customer.

Hence, there was a strong reason to believe that there is every chance of committing a cognizable offence under NDPS Act and to check the veracity of information, I reduced the information in writing vide Matigara PS GDE No. 1785, Dated 20.05.2025 and I intimated the information to Shri Arindam Bhattacharjee, I/C Matigara PS, SPC who brought the information to the superior and after obtaining necessary order at about 15.15 hrs myself, with my van party team, consisting of c/ 1485 Abhishek Saha and C/ 447 Raj Kishore Das and as per the direction of IC PS assisted by Matigara PS team consisting of S.I Rabindra Nath Sarkar, ASI Pema Dorjee Sherpa, ASI Chandra Prakash Adhikary, LC 1286 Anisha Chhetri all are of Matigara PS, SPC and they also took departure vide C.C. No- 2316 dated 20.05.2025 from Matigara PS, SPC for Babalokhnath Colony, Simultala under Matigara PS with an investigation kit containing envelope, white paper, sealing wax, gum, seal, digital weighing machine and other investigation kits by a Govt. vehicle to work out the information and the same was diarized vide Matigara PS GDE No. 1787, dated- 20.05.2025

At the same time I also informed the videographer namely Somnath Chatarjee, S/O- Sushil Chatarjee of Aurobindo Pally, Gokhel Road, W/No. 22, PS- Siliguri, Dist- Darjeeling to be present at Bablokknath Colony Simultala, under Matigara PS, SPC to prepare the video of whole process of search

and seizure if any. On 20.05.2025 at about 15.45hrs, we reached Babaloknath Colony Simultala under Matigara PS and I met with my source and he briefed me about the detailed information and told me that the suspected persons are inside the particular house in Babaloknath Colony under Matigara PS before that I looked up for public witnesses to the entire process of search and seizure if any. I found so many people but two of them gave their willingness to act as independent witnesses. The particulars of the witnesses are as follows 1). Parakhit Chowdary S/o Abhimanyaw Chowdary of Babaloknath Colony Simultala PS Matigara Dist Darjeeling and 2) Kulish Roy S/o Sudir Ch. Roy of Babaloknath Colony Simultala PS Matigara Dist Darjeeling and I briefed them about the information we had and requested them to stand as witness, who agreed to stand as witness during the process of search and seizure and other processes thereafter. Accordingly we proceed towards the suspected house.

In the meanwhile, I/C, Matigara PS sent a message to SDO, Siliguri to depute an Executive Magistrate during search & seizure of NDPS substances as per norms vide Org No- 1520/2025, dated- 20/05/2025. But after a telephonic conversation, it came to know that due to engaging in other duties and short notice, there are no Executive Magistrate available to perform the duty.

In the above circumstances and the gravity of the information, if any delay occurred, the accused persons may escape. Hence, as per order of superior, I/C, Matigara PS directed Shri Sajal Roy, Inspector of Police, Officer in Charge of NBMC OP under Matigara PS, SPC to be present at the place of occurrence to supervise the search & seizure if any. Informed to the same to Shri Sajal Roy, Inspector of Police, Officer in Charge of NBMC OP under Matigara PS, SPC regarding the same.

At about 16.35 hrs, after some efforts my source identified the suspected the particular house at Babaloknath Colony, Simultala under Matigara PS with persons inside the house leaving the door ajar. As earliest I along lady force and other police personnel we managed to apprehend them. I introduced myself and the raid team members as Police officers. I appraised them about the information in hand and started to examine her and others thoroughly. On interrogation they disclosed their names and address as mentioned above. On interrogation the detained three persons confessed that they are possessing and selling suspected to be Brown Sugar to their designated customer clandestinely.

As per provisions of section 50 of the NDPS Act, 1985 (as amended) I explained to the above noted detained three persons that they have the legal right to tender their personal search in front of an Executive Magistrate or a Gazetted Officer and the same was given to them in writing. In reply they wanted to be searched before any police officer. At about 18.15 hrs Shri Sajal Roy, O/C NBMC OP under Matigara PS in the rank of Inspector of Police arrived at the spot as a Gazetted Officer where I briefed him the information in a nutshell. Also introduced the witnesses as noted above.

On further interrogation, the detained persons confessed in front of the Gazetted officer that they were in conscious possession of a huge quantity of Brown Sugar which were kept and concealed in the inside room.

Thereafter, in presence of the Gazetted officer, and the two independent witnesses, I along with the help lady constable and other Officers and force of Matigara PS searched the room inside the house found 1) One packet(transparent) containing weight 1 kg 260 gram suspected to be brown sugar 2) One packet(transparent) containing weight 780 gram suspected to be brown sugar 3) Two packets of white colour Powder in one plastic bag containing weight 9 kg 268 gram style as Sodium Carbonate 4) One bottle of water like substance approx 2 litre and 5) One bottle containing 500ml of Acetyl Chloride 6) Total sum of Money Rs 12, 64,200. /- (Twelve lakh sixty four thousand and two hundred only) Denomination (Rs 500 x 2416=12,08,000/-, Rs 200x221=44,200/- & RS 100x120=12,000/-) 7) One vivo phone IMEI No. 8686750079184498. 8) One Vivo phone IMEI no. 864604671428 and 9) One techno Phone IMEI No. 355792116672927, from their possession that was kept and concealed the inner room of the house.

On interrogation, they stated that they brought the suspect to be brown sugar from Malda and used to manufacture the same at their house since long and deliver to their designated customer at Matigara area for wrongful gain. Then, I asked them to produce the valid license/ documents for

carrying and possessing the huge quantity of illegal narcotics contraband articles but they failed to produce any legal papers.

After weighing the transparent plastic packet which was found in the possession of the detained person is weighted 2 kg 40grams. Thus, a reasonable belief having been formed that an offence has been committed in contravention of the NDPS Act and that recovered articles were liable to be confiscated by the NDPS Act. Accordingly, I seized the above noted articles under proper seizure list duly prepared by me in presence of independent witnesses and Sri. Sajal Roy inspector of police, O/C NBMC OP under Matigara PS, Siliguri Police Commissionerate who acted as Gazetted officer. I also took signatures of the witnesses, the accused person and Gazetted officer and submitted my signature as a seizing officer. Copy of the seizure list was given to the detained persons


Thereafter, 2kg 40gram (two kh forty gram) suspected to be Brown Sugar and other two packets of white colour Powder in one plastic bag containing weight 9 kg 268 gram style as Sodium Carbonate 4) One bottle of water like substance approx. 2 litre and 5) One bottle containing 500ml of Acetyl Chloride have been properly marked and labelled. Took signature of witnesses and accused person in the label in presence of the Gazetted officer.

I then arrested the above noted accused persons after informing them the grounds of arrest for the possession and keeping the illegal contraband drugs under the NDPS Act and issued an arrest memo to them accordingly, duly signed by the accused persons and witness.

The entire process of Search, seizure, Label, Seal and arrest were done in between 18.25 hrs to 19.50 hrs. The entire process of search, seizure, sealed and labeled under the supervision of Sri. Sajal Roy, Inspector of Police, O/C NBMC OP under Matigara PS, Siliguri Police Commissionerate acted as Gazetted officer and video graphed of search and seizure conducted through the camera of Somnath Chatarjee, S/O- Sushil Chatarjee of Aurobindo Pally, Gokhel Road, W/No. 22, PS- Siliguri, Dist- Darjeeling in compliance with the Order of Hon'ble High Court, Kolkata.

Under the above noted fact and circumstances you are requested to kindly lodge a FIR under proper section of law and arrange for its investigation against accused person namely i) Sonam Sha(24yrs), W/O Ohidur Sk. Of Babaloknath Colony, PS- Matigara, Dist- Darjeeling, (ii) Ohidur Sk(27 yrs), S/O Jamul Sk of Narayanpur, PS- Kaliachak, Malda, (iii) Abdul Rauf(30 yrs) S/O Badiruddin of Mouvyawadi, PS- Kaliachak, Maldar)) who are involved in this racket.
