Sub- Written Complaint against Sandip Pradhan.

Respected Sir,

This is to inform you that Smt. Swagata Chakraborty, w/o Late Nitai Chakraborty, (aged about 56 years), resident of Kalamjote, Near Shantiniketan Apartment, P.O. Sushruta Nagar, P.S. Matigara, Dist-Darjeeling, Pin - 734012. That ~~Today~~ ^{yesterday} around 08.30 pm i.e. on 20/05/2025, I was doing my regular work at my CP DEN shop namely 'Deb food Court' situated at Thiknikata, P.O. Sushruta Nagar, P.S. Matigara, Dist-Darjeeling when one of my staff namely Sandip Pradhan, s/o Late Ram Bahadur Pradhan, resident of Kalamjote, P.O. Sushruta Nagar, P.S. Matigara, Dist-Darjeeling started to quarrel with me at my shop while being under influence of alcohol. Although I did not pay as such attention toward his bad behaviour but all of a sudden he started to break my furnitures of the shop and demolishing my shop. When I requested him to stop his wrong doings, he got more furious and started beating me with fist and kicks. He punched me in my right eye and since then I am unable to see through my left eye clearly. He even blow kicks at my head and chest area while I lying down on the floor for saving myself at that situation. I was shouting for his mercy but the above named Sandip pradhan did not listen to my words and continued beating me and destroying my shop. Although he was beating me continually, he further stated that he will kill me and my entire family within 3 months from today and if I try to get any kind of help from anyone he shall destroy my shop and I.

I therefore being helpless at this situation I am writing you this complaint to take appropriate legal action against the said Sandip pradhan as I am unable to see through my left eye and suffering from unbearable pain in my head and my chest region.
